and

Agricomp Machineries and Construction Corp. represented by Engr. Rolando G. Rupac, VP-Operations/ Sales, with office address at Tagaran, Cauayan City, Isabela.

WHEREAS, the Entity has invited the Bidder for the Supply, Delivery, Installation And Testing of Brand New Recirculating Mechanical Dryer in San Mariano, Isabela (hereinafter called "the Goods") for which the entity accepted the Bid amounted to Twenty One Million Two Hundred Twenty Eight Thousand Four Hundred Eighty Pesos and 00/100 (PhP21,228,480.00) of the Supplier for the provision and completion of such goods.

 - (k) Notice of Award of Contract and the Bidder's Conforme thereto;
 - (1) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
