Contract Agreement

THIS AGREEMENT, made on the 18th day of June 2019 between the **Provincial Government** of Isabela with office address at Provincial Capitol, Alibagu, City of Ilagan, Isabela (hereinafter called the Entity")

and

Mac Tycoon Marketing represented by Mr. Mario A. Claus, Proprietor, with office address at 1560 Bambang St., Sta Cruz, Manila.

WHEREAS, the Entity has invited the Bidder for the Supply and Delivery of Various Medical Equipment for the Province of Isabela (hereinafter called "the Goods") for which the entity accepted the Bid amounted to One Million Nine Hundred Seventy Four Thousand Nine Hundred Twenty-Five Pesos and 75/100 (Php1,974,925.75) of the Supplier for the provision and completion of such goods.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form and Price Schedule, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's Conforme thereto;
 - Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
