FOREST COSERVATION AND ENVIRONMENTAL MANAGEMENT DIVISION

A. Forest Resources Development Activities:

1. Nursery Operations & Maintenance Works

For the month of March, we have a seedling stock of **19,725** to include the 270 fruit bearing seedlings procured. A total of **1,130** assorted fruit and forest trees seedling has been disposed to different clients, which include those distributed during the conduct of Farmers' Congress Reloaded at the Municipality of San Mateo, Isabela. Due to inevitable weather conditions, we incurred **1.9%** mortality equivalent to **374** seedlings. The remaining stock balance as of March 31, 2018 at the Provincial Nursery is **18,221**.

b. For IDRRIP planting stock nursery, the remaining balance as of end of March is **6,000** forest tree seedlings. The ISEP-TF assigned at Sitio Lagis Patrol Base Camp take turns in nursery maintenance activities.

2. Activities Undertaken in Support of IDRRIP

a. Monitoring and Documentation

- ✓ Updates on the road situations
 - The road is still close for all types of vehicles except for construction and monitoring purposes due to the landslides that previously occurred during the rainy season; but motor cycle riders coming in could hardly be stopped at the checkpoint especially those who claim to be from Divilacan side;
 - On-going clearing operations by the contractor, passable up to Km. 48;
- ✓ Alleged kaingin-making and clearing of areas within the vicinities of the road projects;
 - At km 21, a certain person identified as Damulag Anudon and son Marvin has clearings involving some IPs as laborers in the persons of Pokhang, Ube and Mumal;
 - At km 13 to 17 (Mannol site with kaingin going to Abuan River) - a certain Ricardo Gamino, Jr. of sitio Lagis invited 12 people from sitio Dibuluan, Minanga, San Mariano and Cabise 27, City of Ilagan, Isabela; and
 - Reports are being prepared for endorsement to DENR concerned CENRO for their appropriate action.

- b. Continuous re-sizing of the cut trees at the log pond
- c. Nursery Maintenance and Protection of the Reforestation Area
 - ✓ Maintenance of the IDRRIP planting stock nursery;
 - ✓ Maintenance of the reforestation sites thru replanting, grass cutting and fertilizer application;
 - ✓ Site preparation activities for tree planting; and
 - ✓ Application of organic fertilizer at the CMP planting site between km 22-23.



- d. Foot patrol works;
- e. Conduct of home and cross farm visits among the Sitio Lagis community;
- f. Provision of regular food packs, dental and medical assistance to the Agta communities along IDRRIP;
- g. Coordinated with PSWDO and OPE for the installation/putting up of the Agta Rattan Furniture Shop at Agta Village in Cabisera 10 the soonest possible time; and
- h. Conducted the Multi-partite Monitoring Team (MMT) Field Monitoring activity with the members of the MMT from different sectors and government agencies and NGO.



B. Forest Protection and Law Enforcement:

1. Manning of Checkpoints

The roving teams conducted surveillance, foot and mobile patrolling to detect illegal gathering and transport of forest products. They act and respond on tipsters (SMS) reports regarding violations of PD 705. Personnel assigned at Sitio Lagis conduct forest protection activities and at the same time perform nursery activities, maintenance, protection and monitoring of the IDRRIP plantation areas.

As a result of the regular forest protection activities, one of the issues raised by the ISEP-TF based in Sitio Lagis is the occurrence of *kaingin* activities. The Office brought the matter to the attention of the DENRO-CENRO Naguilian which is under their territorial jurisdictions. As a result, the CENRO called for a dialogue with the first two (2) settlers that were identified within the proposed IDRRIP reforestation area. Planning for the joint actions with DENR-CENRO, PGI-ENRO and City ENRO is in progress.

2. Apprehension/Confiscation of Illegally Gathered/Transported Forest Products

For the month of **March, 2018**, a **total of 4,939.99 board feet** of forest products were apprehended and confiscated in favour of the government, broken down as follows:

The above apprehended forest products (lumbers & fitches) are now under the PGI-ENRO's custody for safekeeping.

3. Donation of Forest Products

A total of **57** pieces equivalent to **2,287.95 board feet** of common hardwood species were donated for used of the Provincial Government projects.

C. Search for the Most Environment Friendly Barangays

The Office has received **Twenty Seven (27) entries** for the *Search for Most Environment-Friendly Barangays* from the City of Cauayan and Municipalities of Cabagan, Cabatuan, Burgos, Jones, Quirino, San Isidro, Naguilian, Palanan and Dinapigue. Pre-evaluation of the entries shall be conducted on April, 2018 and final validation shall be on May 2018. Winners shall be announced on June 2018 in celebration of the Philippine Environment Month.

D. Updating of the Provincial 10 – Year Ecological Solid Waste Management Plan

Updating of the Provincial 10-Year ESWM Plan is still on process. Out of the 36 cities and municipalities, 33 have already furnished the province copy of their plans for consolidation. As of March 28, 2018, 70% of the updating process is already accomplished. The Office aims for the completion of the updating by the month of April 2018.

E. Vermi-composting Facility

For the month of March 2018, a total of **One Thousand Six Hundred Twenty (1,620) kilograms** of vermicasts (organic fertilizer) were produced. On the other hand, a total of **Six Thousand Nine Hundred Forty (6,940) kilograms** organic fertilizer were disposed and utilized at ENRO Provincial Nursery. Said volume was sourced out from the stock produce of 2017.

F. Information, Education and Communication (IEC) Campaigns

- a. For. Cecilia M. Asuncion served as Resource Speaker during the Ecological Solid Waste Management Seminar conducted by the Municipal LGUs of San Manuel and Quirino, Isabela with the Municipal Councils, Barangay Officials, Teachers, Youth and other concerned residents as participants.



- b. For. Rosemarie T. Zabala and For. Dalisay A. Baligod served as resource speakers during the Environmental Awareness Campaign organized by Senior High School students of the Isabela School of Arts and Trades with focus on Republic Act 9003, Urban Greening, Forest Tree Parks Establishment and Forest and Environmental Laws. This was conducted in Barangay Osmena, City of Ilagan with participants coming from barangays Osmena, Calamagui 1st and Calamagui 2nd.


