Production/Propagation and Disposition of seedlings	Production, propagation and procurement of seedling stock and disposition of seedlings	For this month, germinated seeds of Antsoan Dilaw and Molave tree species were transplanted and are yet to be inventoried when recovered.  Number of seedlings produced: A total of 1,100 forest tree seedlings were produced comprising of 75 Balitbitan and 1,025 Ipil seedlings, respectively.  Number of seedlings released: A total 1,159 assorted seedlings were disposed to various requesting constituents composed of 567 forest tree seedlings, 512 fruit-bearing tree seedlings, 58 bamboo propagules and 22 Palm;  Stock balance: 30,026 seedlings as of July 31, 2022.	
b.Maintenance works	Maintenance of Provincial Nursery; Operation of Clonal Nursery; Brushing, ring weeding and greening of two nurseries; arrangement, and sorting of seedlings for hardening; seed and collection and propagation; and other activities that may be assigned to be accomplished during the period	Supervised and led by ENRO personnel assigned, 2 contractual and 4 job-order service providers ensures the conduct of regular maintenance and operations of the nursery. Activities include improvement of seedling beds, soil potting, transplanting and sorting of seedlings. Further, soil media for the cloning beds were also prepared.  Also, ENR Personnel and some members of ISEP-TF Operatives joined in the conduct of clean-up drive and nursery beautification Activities include landscaping, weeding, grass cutting, watering of seedlings, sorting of seedlings and proper disposal of rotten Polyethylene bags.

The group were able to haul 12,500 seedlings which consist of: 4,000 Molave/Sagat seedlings; 2,000 pieces, Bignai; 1,300 pieces Kalumpit; 2,600 pieces Dau; and 2,600 pieces ipil seedlings. These seedlings shall be utilized for the Watershed Rehabilitation Projects for 2022.  On July 21, 2022, this Office through its personnel supervised the implementation of watershed rehabilitation project at Sitio Namnama, Brgy. Santos, Quezon, Isabela. A total of 4,400 seedlings ocomprosing of Molave, Kalumpit, Ipil, Bignai and Bamboo propagules were planted in the (4) hectares forest land within the Quezon Municipal Eco Park. The project is a continuation of support provided to LGU Quezon with the improvement of the previous established plantations within the said location, which were also visited to monitor maintenance activities employed by the partner LGU.




