POST FARMERS' CONGRESS REPORT September 23, 2014 LGU Tumauini, Isabela

Around 7:00 o'clock in the morning, the registration started upon arrival of participants coming from the different Barangays of Tumauini. Afterwhich, the Farmers' Congress properly commenced at 8:45 AM following the presentation of the different programs and services of the Provincial Government to which Mr. Raymel Resposo of BRO Scholar Opportunities gave the overview of the program and presented in a nutshell all the services the farmer can avail from it and where put all together in a package to start (BROs ASP, PPP, PSP, LAMFP, PAIWI and livelihood); Health (BROs Healthcare & PhilHealth); Insurance (BROs PNB Gen & SSS) and Scholarship (BRO Education) for their children. It was followed by brief presentation of focal persons with their respective services.

At 9:30 AM, the Provincial Governor Hon. Faustino G. Dy III together with Vice-Governor Hon. Antonio T. Albano arrived at the venue and delivered their message to the community and promised to support all its undertakings as well as the construction of bigger Community Center for their consumption. Togerther with him is Hon. Ricjay Angobung, Board Member of 1st District of Isabela, showing also his support and gave the welcome address. Hon. Mayor Arnold Bautista expressed his great appreciation to the whole Provincial Government during his speech for bringing the services to his contituentst. The governor mentioned in his speech that they awarded financial assistance to the forty six (46) Barangays covering the Municipality of Tumauini amounting to Php 150,000.00 (Php 100,000.00 for insfrastructure and Php 50,000.00 for Fiesta, Lakbay Aral, Health Insurance & Iglo each as provincial counterparts to be implemented at the Barangay Level). During the program, representative from the National Food and Authority (NFA) awarded the governor and the whole Province of Isabela for being the Quality Corn Achiever/Producer amounting to more than three million (3,000,000.00) pesos in its honour and assured the people that said award will be equally distributed to all LGUs of Isabela.

Subsequently, after showcasing the basic services of the Province, this office through its focal person formally opened the table to entertain and assist the issues and concerns of the constituents bringing with them their routine slip about environmental services, we were able to cater eleven (11) clients with their concerns as follows:
