A change in leadership, adjusting to the way of life through this pandemic, re-organization. Here's a glimpse of PSO CY 2022.

A. Changes in the Organization

Atty. Constante A. Foronda, erstwhile PSO Department Head had to trans-

fer to the PDRRM Office for his official assumption of duties as Isabela Provincial Disaster Risk Reduction and Management Officer (PDRRMO) exactly 6 months into the year while Kim Patrick G. Agbayani, Assistant Department Head was designated Officer-In-Charge (OIC-PSO) by virtue of GRTA Special Order No. 43 S. 2022 which was presented by Isabela Provincial Administrator Atty. Noel Manuel R. Lopez, CPA, last July 4, 2022 at his office. As first order of business, OIC-PSO Agbayani then proceeded to bring change to the organization by restructuring the Administrative, Operations and Training Sections to ensure proper tasking and distribution of responsibilities within the group albeit with only a few

personnel to allocate per section.

B. PGI awards 2 high performance vehicles to the HPG Isabela Provincial Highway Patrol Team, Regional Highway Patrol Unit 2

The Province of Isabela, through the Public Safety Office then headed by Atty. Constante A. Foronda, Jr., awarded 2 CFMOTO high performance motorcycles to the HPG Isabela Provincial Highway Patrol Team, Regional Highway Patrol Unit 2 to provide needed equipment as part of the Road Safety program being promoted by the Province. Present during the awarding to receive the 2 units of Motorcycle at Cauayan City was P M A J O R G r e g Sanchez, Provincial Officer of the HPG.

C. Isabela Emergency Hotlines

THE Isabela Emergency

Hotlines, updated Quarterly for the benefit of all residents and visitors of the Province is being published and sent to all PGI Departments and Isabela stakeholders through email and social media.

D. Safety Officer Training / Continuous Learning

The Provincial Government, in it's commitment to provide necessary learning on safety procedures and increase the PGI workforce's capacity in terms of Safety Awareness and Safety Officer roster, has successfully trained 114 new First Responders to replace transferred / inactive / retired members and conducted a refresher course for 87 active members. The trainings were conducted in 6 batches starting the month of March with the last batch of refresher training conducted last May 30-June 2, 2022. A 1 day refresher on Traffic Laws and Road Safety was also held for the iSMART riders.



# THE PUBLIC SAFETY OFFICE

The **Isabela Public Safety Office** traces its humble beginnings to February 21, 2012, when Ordinance No. 001 Series of 2012, entitled “AN ORDINANCE CREATING AND ESTABLISHING THE DEPARTMENT OF PUBLIC SAFETY IN THE PROVINCIAL GOVERNMENT OF ISABELA AND PROVIDING FUNDS THEREFOR” authored by Sangguniang Panlalawigan Member Hon. Rolando L. Tugade, Chairman of the Committee on Public Security and Order, was enacted.

It was later amended by Ordinance No. 002, Series of 2014, entitled “ORDINANCE CREATING AND ESTABLISHING THE PUBLIC SAFETY OFFICE THE PROVINCIAL GOVERNMENT OF ISABELA AND PROVIDING FUNDS THEREFOR”, authored by Sangguniang Panlalawigan Member Hon. Karen G. Abuan, Chairman, Committee on Laws, Rules and Regulations.

The functions of the Office:

(a) To enforce provisions of Ordinance No. 0002-2001 otherwise known as the Provincial Administrative Code, particularly Chapter IV, Provincial Gov-

ernment Services: Article 1 – Peace, Order, and Security; Article 2 – Public Order; Article 3 – Safety on Public Roads; and Article 4 – Safety on Fire Hazards;

(b) To enforce provisions of Presidential Decree No. 1566 governing the creation of Provincial Disaster Coordinating Council in the Province of Isabela now called the Provincial Disaster Risk Reduction and Management Council (PDRPMC) under R.A. 10121;

(c) To enforce all other laws and ordinances relative to the protection of lives and properties, and those pertaining but not limited to the maintenance of public safety, peace and order especially during man-made or natural calamities, and the promotion of general welfare;

(d) To ensure and provide quick response and coordinative efforts for any call or need of the public for police, fire marshals, rescue or medical assistance;

(e) Exercise the duty to make citizen's arrest pursuant to the Rules of Court; and

(f) Perform such other duties and functions as may be provided by law or ordinance. (Section 5, Ordinance No. 01-2014)

The Office was initially manned by Atty. Constante A. Foronda, Jr. as the Department Head, PBGEN. Jimmy U. Rivera, Sr., (Ret.) the former Provincial Director of Isabela Police Provincial Office (IPPO) as Assistant Department Head and Mr. Jose Armand G. Araneta.

Nine (9) years since its creation on January 21, 2014, Public Safety Office has evolved into what it is now. It initially shared office space with the Office of the Governor, until the District Office of then 1st District Representative Hon. Rodolfo “Rodito” T. Albano III (Incumbent Governor of Isabela) was graciously offered to be its temporary office, prior to being transferred to the former office of the Provincial Cooperatives Development Office (PCDO) at the rear ground floor of the Isabela Provincial Capitol from 2017 to 2019 before transferring to its current location at 2nd floor of the newly constructed PSO-PSWDO Building, Provincial Capitol Grounds, Alibagu, City of Ilagan, Isabela on December 2019.



# THE ISABELA SPECIAL MOTORCYCLE ACTION AND RESPONSE TEAM



Sometime in late 2015, then Gov. Faustino G. Dy III and Public Safety Officer Constante A. Foronda, Jr. were sharing a ride to an appointment. The ride was a bit long, thus they used the time to discuss concerns of the Public Safety Office. The Governor expressed his increased concern over the number of road crashes in the province and his responsibility to reduce such number. After a discussion of possible solutions, this question arose: "Ano kaya kung bumili tayong mga motorsiklo, tapos pasakyan natin sa PNP para gamitin sa pag-enforce ng traffic at transportation laws?"

Thus the Province purchased sixteen (16) 200cc motorcycles or four (4) units per congressional district (from 4 to 6 congressional districts by virtue of Republic Act No. 11080 creating two more districts in the province of Isabela last 2018).

Sixteen (16) police officers were initially selected from among those nominated by the Isabela Police Provincial Office (the "IPPO", for brevity). Each went through the rigorous Motorcycle Riding Safety Seminar of the Highway Patrol Group; First Aid, Basic Life Support, and CPR Training of the famed DART Rescue 831; and Deputization Training of the Land Transportation Office (the "LTO", for brevity).

On June 20, 2016 the sixteen (16) motorcycles were turned over by the Provincial Government to the PNP and the riders made their first public appearance as a group. Thus the birth of iSMART or the Isabela Special Motorcycle Action and Response Team.

As law enforcement officers deputized by the LTO, iSMART riders apprehended motorcycle drivers that violate traffic and transportation laws, including riding an unregistered motorcycle, riding without a valid license, riding without helmet, carrying excess passengers, unauthorized motorcycle modifications.

In 2016, Memorandum Order No. 46-2016 was issued by Gov. Dy which institutionalized the data collection and analysis of road crashes in the province to determine the Engineering, Enforcement, or Education intervention that is needed. Despite the efforts of the 16 iSMART riders, the number of road crashes further increased from 2,393 in 2015 to 2,744 in 2016 based on the data of the Isabela Police Provincial Office.

Believing that law enforcement is the key to the reduction of the number of road crashes, in 2017 the Governor ordered the purchase of eight (8) additional motorcycles and then ordered the purchase of another twenty-four (24). Forty-eight (48) motorcycles were turned over by Gov. Dy to the PNP.

With 48 iSMART motorcycle units operating, the number of road crashes finally decreased to 2,471 in 2017 from 2,744 the previous year based on the data of the Isabela Police Provincial Office.

The iSMART kept improving its operational systems and the number of road crashes in 2018 plummeted to 1,867.

Since it started operating in June of 2016 the iSMART accomplished the following:

It appears that the presence of iSMART on roads acts as a deterrent to would-be violators. The fear of the trouble and expense of being cited for violations of traffic and transportation laws have compelled motorcycle riders to be compliant.

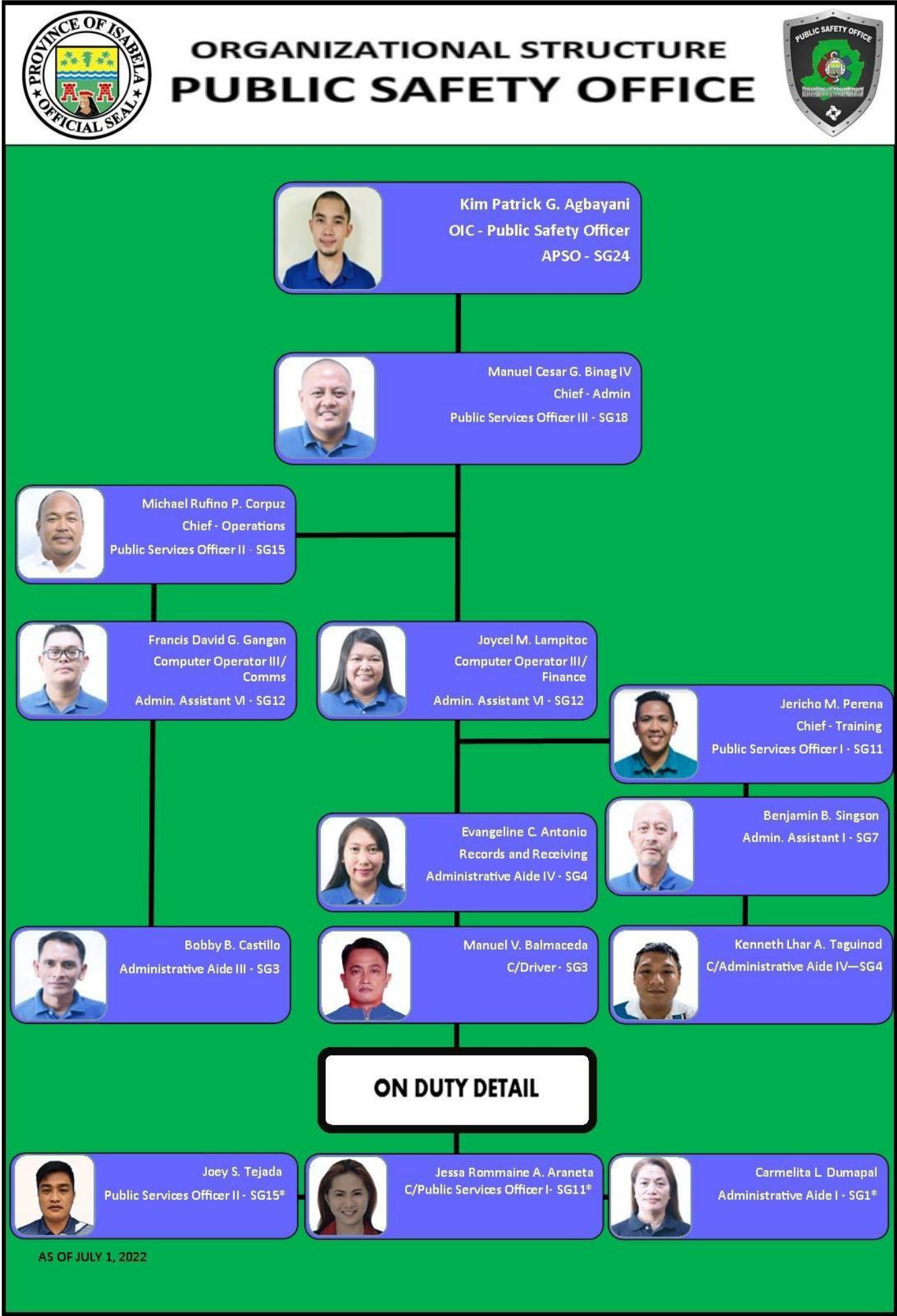
Furthermore, with the presence of iSMART on roads other crimes that involve the use of motorcycles have either reduced in number or disappeared. Go to the barangays and you will find that almost 100% of motorcycle riders do not wear helmets. The reason for this is that there is practically no traffic and transportation law enforcement in the barrios. Barangay officials are included in the officers enjoined by EO 18 to enforce traffic and transportation laws. Sadly, violations are rampant in the barangays. For 2022, 30 riders remain in the roster as the others are re-assigned/promoted/transferred to another area.

To ensure continuous learning, a 1 day refresher seminar/workshop was held last September 1, 2022 with lecturers from the Land Transportation Office - Region 2.

If the goal to achieve the number of iSMART motorcycles and riders increased to 72 in in the near future, there will be sufficient units to operate in the barangays as each district will already have 12 iSMART riders operating in their area. Knowing that iSMART officers can be anywhere at anytime, motorists will have to be compliant with traffic and transportation laws because they can be apprehended anytime anywhere.

Other local government units may attain reduced rate of road crashes and rate of crimes involving motorcycles if they would adopt their own versions of the iSMART system.





# THE PSO SHIELD

The PSO Shield was designed to formally establish the identity and purpose of the Public Safety Office which was created by virtue of Sangguniang Panlalawigan Ordinance No. 002 series of 2014 on January 21, 2014.



**THE SHIELD** The shield signifies protection from danger, risk, or any unpleasant experience.

**Black Color of the Shield** Signifies power, unity and strength.

**Map of Isabela** The Map is in green color indicating the province’s status as one of the top corn and rice producers of the country. It is presented with demarcation lines indicating 34 towns and 2 component cities which makes it the 2<sup>nd</sup> largest province of the Philippines. It was initially called *Isabela de Luzon* to differentiate from other places within the Country bearing the name of Isabela. The province was named after Queen Isabela II of Spain.

**The Official Seal** The Official Seal of Isabela is super imposed on top of the Malta Cross and Star of Life to signify the province’s readiness to respond in all types of emergencies.

**The Maltese Cross** Symbolizes the good traits of a safety officer as being observant, tactful, resourceful, dexterous, explicit, discriminating, perseverant and sympathetic.

**Star of Life** is a blue, six-pointed star, outlined with a white border which features the rod of Asclepius in the center. Traditionally, the logo was used as a stamp of authentication or certification for ambulances, paramedics or other EMS personnel. Internationally, it represents emergency medical services units and personnel.

**The Four Connected Hands** is a symbol of togetherness and participation. It signifies the unity of various units within the government working hand in hand to ensure the safety and well-being of its residents.

**The People** A group of 36 persons, representing the 34 towns and 2 component cities of the Province of Isabela linking together, to provide a full and unified front against all adversities and elements that may compromise the safety and well-being of its residents.



## PUBLIC SAFETY OFFICE ACCOMPLISHMENTS FOR THE YEAR

*Although the Public Safety Office responds to safety and/or order events with the coordination with police, fire, rescue, medical, and social welfare groups, it prides itself in taking a proactive stance that focuses on providing solutions to problems before they even arise. This is done through recommendations by the Public Safety Office to the proper agencies on matters pertaining to the personal safety and security of Isabeleños in times of calamities and disasters, crime waves, terrorism and other forms of security threats.*

The Office have several accomplishments in the promotion of public safety in 2022. They are the following:

- 1) Caused the training of 3 batches of 114 new First Responders to replace transferred / inactive / retired members.
- 2) Conducted a refresher course for 87 active members of the PGI Safety Officer core group.
- 3) Joined and supported the Quarterly National Simultaneous Earthquake drills in full coordination with the Office of Civil Defense - Region 2,



- 4) Caused the turn-over of 2 CFMOTO High Performance Motorcycles to the HPG Isabela Provincial Highway Patrol Team, Regional Highway Patrol Unit 2 as part of the PGI's commitment to it's Road Safety Program.

- 5) Submit recommendations/situational reports to the Provincial Governor regarding matters concerning Public Safety and Public Order.
- 6) Monitored and updated the Isabela Emergency Hotlines Quarterly for the benefit of all Isabela residents and visitors who might have a need for Police, Firemen and General Rescue assistance.
- 7) Facilitated / attended coordinating meetings and conferences with different line agencies with regards to Safety, Traffic, Parking, Security and Crowd Control arrangements for all PGI major events within the Provincial Capitol grounds and other areas within the Province.
- 8) Continuous production and research of IEC materials as per request and public requirement.
- 9) PSO personnel attended various capacity building seminars and workshops to further improve skills and knowledge on Safety such as Basic Occupational Safety and Health training conducted by the DOLE-OHSC, CSC Supervisory level trainings, Effective Approach in Records Information & Data Management System, Enhanced Local Climate Change Action Plan (ELCCAP) preparation, Incident Command System training for Executives, Reset: Retooling Employees for Service Excellence through Technology training, among others.
- 10) PSO personnel acted as support/augmentation contingent during severe weather related disturbances and assisted PDRRMO counterparts, PSWDO counterparts in their water level monitoring, rescue and relief operations as reserve pilots.
- 11) PSO intensifies Public Information and Awareness on Public Safety Guidelines and procedures through it's Social Media page <https://www.facebook.com/pgipso>, and caused the creation of the PGI Safety Officer core messaging group for im-

- 12) PSO attends ISO 9001-2015 Phase 1 and Phase 2 certification as well as all pre-audit activities conducted by Macro-vision Inc. to ensure full compliance to the standards.

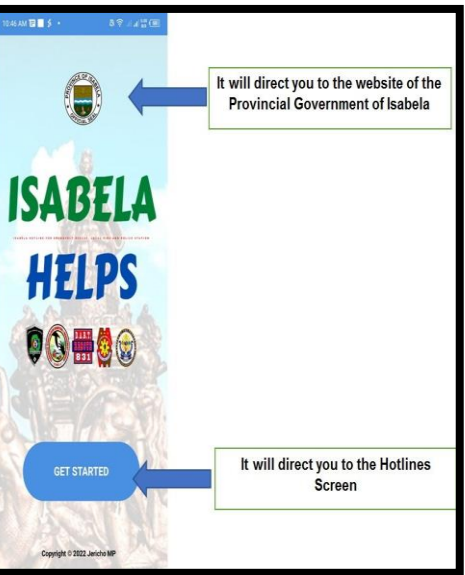

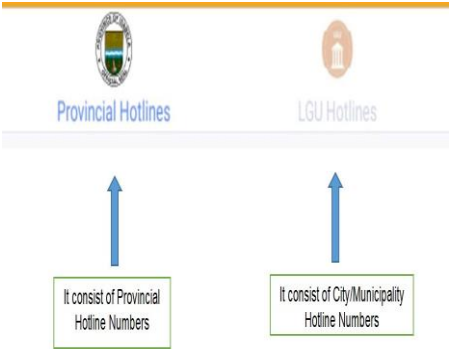

How it works??

- 1. Download the app from Playstore/IOS Appstore. Search for Isabela-HELPS.
- 2. When you open the mobile application, you will be directed to the home screen.
- 3. If you want to know more about the Provincial Government of Isabela just click its logo.



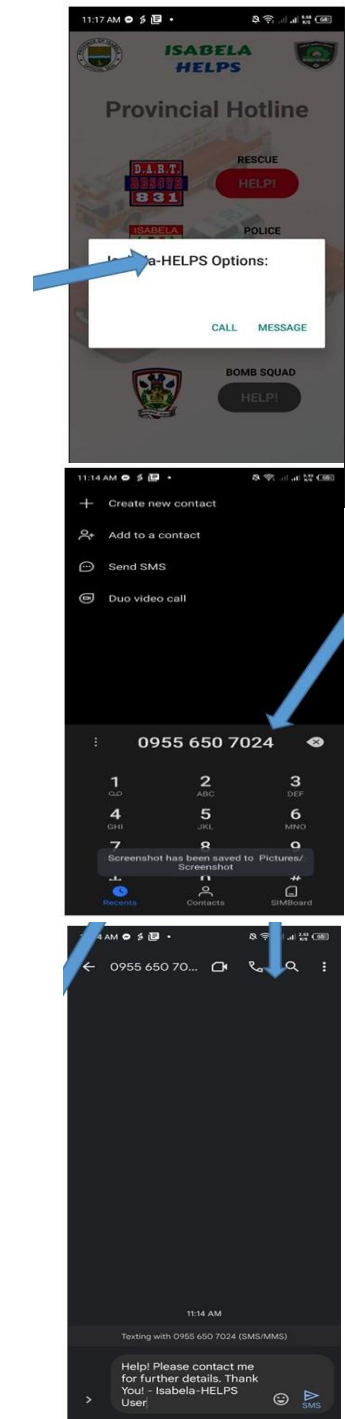
4. Click get started, then you will be directed to a new screen where it shows bottom navigator buttons to choose between Provincial Hotlines or LGU Hotlines.



5. When you choose the PROVINCIAL HOTLINES, you will be directed to this screen. Choose the service you need then click help button then it will let you choose call or message, just click the option that is more applicable for you.



6. When you choose the LGU Hotlines, you will be directed to this screen. Click the city/municipality, choose from rescue, police and fire station depending on your need then it will let you choose call or message.



Although the I-HELPS APP is still in it's developmental stage, testing and actual application has proven that it is a useful tool which will be shared to the General Public once fully operational and with the necessary technical and funding requirements.




Note:

The mobile application contains quarterly updated and consolidated hotline numbers from rescue, police, and fire station of all Cities and Municipalities in Isabela. There is no need to save the hotline numbers one by one in your phonebook, just download the app and you have all the emergency hotline numbers in the Province of Isabela, whenever you need it.
