On January 6, 2025, TL, iSMART conducted PICE among the iSMART personnel regarding LOI "Tamang Bihis" and Internal Discipline.

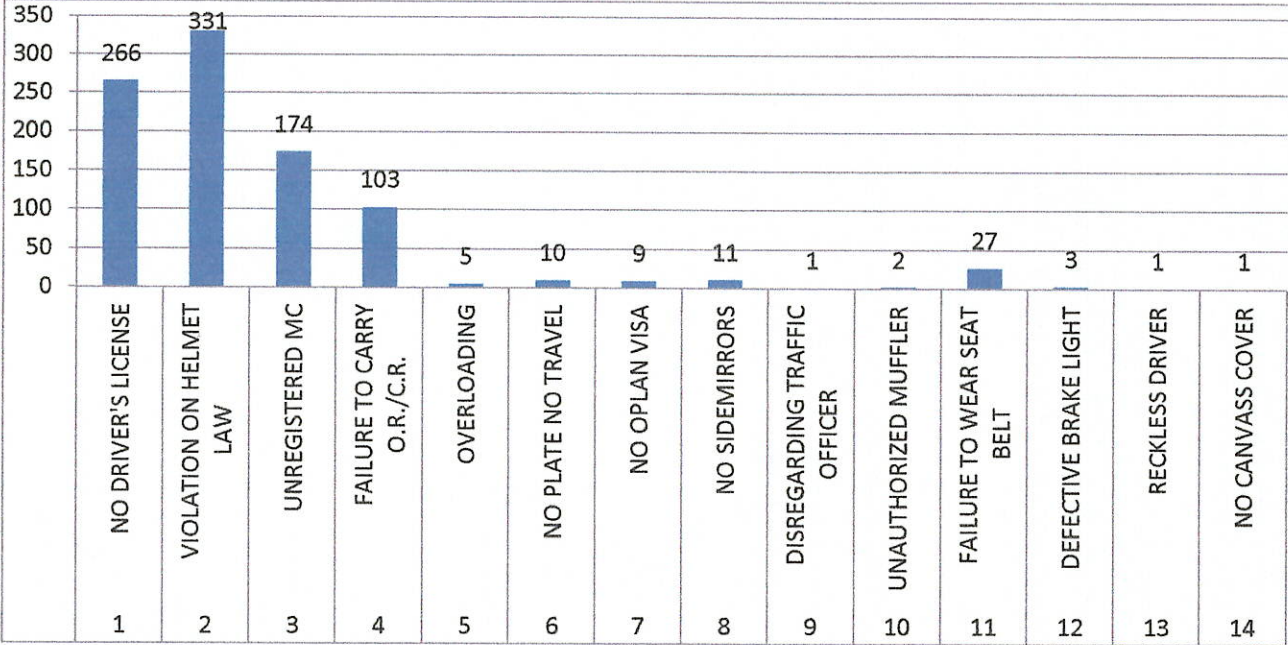
