

Weekly Accomplishment Report January 5 - 23, 2015

REGULAR MEETING OF SENIOR CITIZEN-ISABELA CHAPTER

On January 6, 2015, 1st Tuesday of the month and year the Federation of Senior Citizen Association of the Philippines (FSCAP) – Isabela Chapter thru the Provincial Social Welfare and Development (PSWD) Office conducted its first and regular meeting which was attend by Provincial Senior Citizen Officers and Municipal Chapter Presidents which was held at the SC Day Center, Capitol Alibagu, City of Ilagan, Isabela.

The opening preliminaries were done which started with a short prayer led by the Spiritual Adviser, Mr. Romeo Lacro from Quezon, Isabela followed by the singing of Pambansang Awit conducted by Dr. Luz Torio, OSCA and Federation President of Cabagan, Isabela. A roll call of every chapter was done by Ms. Manuela Malsi, SC Municipal President of Reina Mercedes. A quorum was noted and declared by Mr. Jaime Gelacio, Jr. the Provincial Vice President of FSCAP – Isabela Chapter and at the same time the OSCA and Municipal President of San Mariano, Isabela. Mr. Republic Madamba, the President of FSCAP – Isabela Chapter and the Municipal SC President of Echague, Isabela, delivered his opening remarks by highlighting the 2014 accomplishments/activities undertaken by the Chapter. President Madamba recognized the efforts of every chapter/municipality who actively participated and involved in regular meetings of year 2014. He said that he will be looking forward for a productive and meaningful undertaking of all senior citizen officers in the province.

A newly signed law by his Excellency, President Benigno S. Aquino Republic Act No. 10645 also known as the Mandatory PhilHealth Coverage of all Senior Citizens was discussed by Mr. Alexander A. Arellano, the Chief Social Insurance Officer of the PhilHealth Ilagan Branch. Mr. Avellano further explained its provisions, enrollment, dependents, benefits and availments. Questions were raised by SC participants and these were clearly responded by the speaker with concrete examples of different (illnesses) cases.

Ms. Lilia Castillo, the Provincial Cooperative Development Officer purposely came to meet the Federation Officers to discuss the BRO for Livelihood Development for those chapters interested for livelihood. PCDO Castillo explained that Cooperative, Association or Indigent Individual are qualified to borrow for a Cash Loan. Also, she enumerated different requirements to be able to qualify for this program. She added that anyone who will be interested can come and visit in their office to be able to assist them in the preparation of requirements.

Another agenda which was discussed by Mr. Teodolfo Cadelifña, PMAS General Manager in the Provincial Mutual Aid System (PMAS) is the giving of Death Assistance of P30,000 to the wife of the former SC President of Benito Soliven, Mr. Felipe Etrata who died on December 18, 2014. It was also at that time that Mrs. Ester L. Ambatali, BOD of the Federation, signified her intent to resign as the treasurer of the PMAS since she cannot write anymore due to her fractured arm. Many were nominated but they refused the responsibility due to the distance to the PMAS General Manager and weak health. Mrs. Estelita Mauricio, Treasurer of SC Benito Soliven Chapter was elected and she positively accepted the position as the new treasurer of PMAS-FSCAP Isabela.
