

Activities Undertaken for the Period June 22 to July 10, 2015

On June 22, 2015 twenty-five (25) Former Rebels (FR) were awarded swine under the PAIWI ni BRO and Livelihood Assistance to 13 FRs.



On July 3, 2015 the **BRO – Laban sa Undernutrition Sa Obesity at Gutom (LUSOG)** sa Barangay, the 13th component of the BRO –Small Farmer Assistance Program of the Provincial Government of Isabela, was launched during the Farmers Congress in San Agustin, Isabela. The Supplementary Feeding aims to target malnourished children identified by Barangay Health Workers (BHW) and who were children of Small Farmers. 167 children were benefitted during the feeding on that day.



The PSWD Office staff were on duty during typhoon Egay on July 3 - 5, 2015.

The Comprehensive Local Integration Program (CLIP) regular meeting was conducted on July 6, 2015 at the CLIP Office, Queen Isabela Skypark, Capitol compound, Alibagu, City of Ilagan, Isabela. The meeting focused on the Former Rebels claims and concerns on the different CLIP programs as well as monitoring of the program implementation.



The Federation of Senior Citizens Association of the Philippines (FSCAP) Isabela Chapter conducted its regular assembly meeting on July 7, 2015 at the Senior Citizens Office, Capitol Compound, Alibagu, City of Ilagan, Isabela. The meeting was attended by SC Chapter Presidents with three(3) municipal officers from their respective municipality and provincial FSCAP officers.

The elderly meeting focused on the problems and issues related to Social Pension where Mr. Ferdinand Bainto of the DSWD Regional Office, Tuguegarao City Social Pension Program gave updates and clarifications on the said program. Mr. Bainto explained that this program is coordinated with their respective Municipal Social Welfare & Development Officers(MSWDOs) and OSCA Chairmen.

Board Member Honorable Manuel A. Alejandro also came to visit and join the meeting giving updates on some issues encountered by SC in terms of their benefits such as transportation discounts on public utility vans and small drugstores that does not offer discounts. BM Alejandro reiterated to come up with a resolutions or request letter to managers/owners of this establishment and schedule for a dialogue.



The Office of Civil Defense Director, Dir. Norma Talosig with staff came to visit the Provincial Model Day Care Center (PMDCC) for pre-assessment of the center and its entry documentation with directions and recommendation on July 7, 2015.



The PSWD Staff supports the advocacy campaign on ***“Todas Dengue, Todo na To – Ikalawang Kagat!”*** through cleaning and gardening in areas of the PMDCC up to the Women and Children Protection Center (WCPC) with parents of the day care children and ROTC cadets and cadettes.
