I. Introduction

The Women and Children Protection Center (WCPC) is provincial temporary residential care facility intended for 37 municipalities and cities in the province to cater Women in Especially Difficult Circumstances (WEDC) age ranging from 18-59 years old who are victims of violence against women and for Children Needing Especial Protection (CNSP) age ranging from 0-17 years old who are victims of sexual abuse, sexual exploitation, child trafficking and children age ranging from 0-7 (male and female) who are abandoned, neglected, maltreated, child labor, dependent of clients are all equally eligible for temporary care and temporary shelter.

The center has the capacity to accommodate 20 to 22 clients. It is open and available 24 hours in a day for inquiries and referral of clients. The center has an existing rehabilitation team, compose of Pediatrician, Teachers, Dentist, PNP women's Desk officer, Lawyer of Provincial Legal Office, Provincial Administrators Office, MSWDO and Psychometrician and Psychologist who used to stand and defend the Psycho Social well-being of clients. The Center has a complete facility specifically furniture, fixtures, outdoor play facility, various rooms, other areas needed for level I and level II standard. The center had maintained and sustained level II standard with existing certificate of accreditation valid for 5 years, from June 29, 2021 to June 30, 2026 respectively. There are 18 staff and 3 lady guard managed the operation of the center which compose of 4 Social Workers, 2 Psychometrician, 1 Nurse, 6 House parents, 1 clerk, 1 cook, 1 utility, 1 laundry worker and 1 administrative aide I all are permanent position except for the 3 newly hired contractual employee but with existing item created and funded subject for deliberation before end of December 2023.

The Provincial Government of Isabela allocated and appropriated regular fund for the operation of WCPC calendar year 2022 that includes the Personnel Services and benefits of 18 staff, Maintenance and Other Operating Expenditures (MOOE) and Gender and Development Fund (GAD) in the amount of P 10,020,143.00 as against the previous year budget 2021 with an allocation of P 9,133,068.00 an increase of P 887,075.00 for the year 2022.

The Faustino N. Dy (GFNDy) Memorial Hospital owned and managed by the Provincial Government of Isabela serves as medical facility for sick clients/wards with free of charge including medicines and laboratories. The accomplishment and compliments for 2022 is the result of collaborative efforts of our PSWDO and WCPC staff through the unending support of Provincial Administrator and through the leadership of our Governor, Rodolfo T. Albano III, Vice Governor Bojie G. Dy, III and other elected leaders in the province equally generous and sensitive to the needs of every clients.

B. Programs and Services

1. Home Life Services

The center has structured daily activities designed for women and children. The task assigned to every ward may vary according to their age and capability. The young wards will perform the light task while the big wards perform the hard task with the supervision of houseparent and other staff.

- The center provided complete set of clothing to the 27 clients admitted for the year 2022
- The center provided quality three square meals for the 27 clients.
- Conducted regular meeting with the 27 wards
- Conducted consultation meeting with children having special needs.
- Supervised activities of children
- Conducted monthly character building session to 27 wards. Sustained and practiced 17 center rules and regulation.
- Conducted Home Management Session.



2. Psycho-Social Services

Out of the 4 new admissions, 3 of them have undergone Psychological Testing and Assessment with our partner Registered Psychologist. 10 have undergone re-assessment and individual counseling with the same partner. Out of the 27 total clients served for the year 2022, 25 were administered with counseling and group dynamics conducted by the 2 resident mental health practitioners except for the 2 babies. The residents also enjoyed the play therapy sessions. These psycho-social care activities are all part of their individual intervention plan to process their acquired Post-Traumatic Stress Disorder due to the abusive circumstance that they experienced. The Provincial Government of Isabela through Gender and Development Fund allotted P 100,000.00 this CY 2022 for the Psycho-Social needs of the residents. WCPC was able to use P 31,500.00 of the said fund.



3. Educational Services

For school year 2022 to 2023, there were 22 wards provided school needs. There were 5 wards who are not in school (3 mothers, 2 babies) while the 22 wards were enrolled in the different schools in the City of Ilagan. Among them is 1 college student at St. Ferdinand College, 2 Senior High School 1 in Alibagu National High School and 5 in Alibagu Elementary School. These children were provided transportation allowances for the month of August 2022 to December 2022 face to face classes in the amount of P 63,800.



4. Health Services

- There are 25 wards vaccinated for Covid-19 completed 2 doses.
- There are 2 wards confined at FNDY Memorial Hospital due to Dengue and Typhoid fever and 8 of them had medical check-up due to cold and cough and allergies while 19 of them had Dental check-up through the mobile dental service of the Isabela Provincial Hospital for free of charge including medicines and vitamins for the 27 wards.
- The Residents Nurse assisted 27 wards in maintaining good personal hygiene and assisted 11 sicked wards during their self-medication and isolation period and assisted (2) babies at Barangay health center for their vaccine.
- House parent imposed daily exercise activities for the 25 wards.



5. Legal Services

There were 22 filed cases handled by the (3) three registered and accredited Social Worker and attended 25 court hearing in the different branches of trial court in Region 02.

- Conducted 13 case conferences with MSWDO, relatives or parent of clients, barangay captain and women desk officers.
- Conducted 26 home visitations to client relatives purposely for the preparation of family in reintegration of clients in the community.
- There were 4 clients newly admitted while 6 clients were reintegrated to their family and relatives.
- Out of 22 filed cases, only one promulgated for the year 2022.
- Conducted regular review and briefing of client's case.
- Conducted counseling to clients.
- Updated 16 case study reports and formulated 14 intervention plans for clients.
- Prepared 36 progress reports of clients.
- Presentation and review of 20 cases including (4 admission and 6 client discharge)
- Conducted 12 consultations meeting with the SocialWorkers and Psychometrician.



6. Spiritual Services

As the Covid-19 restriction lifted, the WCPC began accepting spiritual activities such as the conduct of Holy Mass by parish priest of St. Ferdinand assisted by Catholic Women's League (CWL). Other spiritual activities conducted by Born Again Christian groups like bible study and attended online mass like virtual mass and live TV mass.

- Celebrated Dedication of a baby girl officiated by parish priest of ST Ferdinand.
- Regular daily prayer and devotions assisted by houseparents.



7. Recreational, Sports, and other Socio Cultural Activities

Recreational activities outside the WCPC premises is limited due to COVID 19 restrictions, however, we allow children to visits malls nearby the city with some regulations to follow and assisted by House parent and lady guard. They also went to Royal Class Resort to have a fun recreation like swimming and playing. Aside from the outside activities, WCPC also celebrated special events like Women's Month and Children's Month Celebration, Family Week, Birthdays of the residents, and other event like dedication /baptismal of baby girl, Christmas and valentine day. All these activities funded through Maintenance and Other Operating expenditures (MOOE) and GAD fund with appropriation of P 100, 00.00 and expenditure of P 85, 170. Other outdoor facility like monkey bar, see saw, sliding, swing , socio-cultural recreation play, board games , laronglahi and sports game are existing and equally enjoyed by the children in the center.



8. Economic and Livelihood Skills and Development

Through the Gender and Development Fund, the center was able to conduct 5 livelihood trainings. During the first quarter dated March 14-21, 2022 training on dressmaking and pattern making was availed by 13 WCPC residents, 10 mothers/relatives and 6 houseparents. Beauty Care was conducted last March 29- 30, 2022 as part of culminating activity during Women's Month Celebration. Meat Processing and Pastry Making conducted last October 8-9, and 15-16, 2022 participated by 11 residents, 6 mothers/relatives and 6 houseparents. Lastly, training on housekeeping and body massage conducted December 19-23 2022 participated by 13 residents, 6 mothers/relatives and 6 houseparents. The 5 trainings conducted were participated by the residents and mothers/relatives and house parent. The family members and relatives were involved in this training so that comes reintegration the family is already economically sustainable and self-reliant. The Provincial Government of Isabela also approved fund for the provision of seed capital for the trainees who are qualified and passed the TESDA certification.



9. Financial Assistance/Shelter Assistance

There were 3 clients provided Financial and materials assistance for the repair of their dilapidated/shanty house and construction of small house for the homeless clients. Completion of the project is through a joint effort of the Provincial Government of Isabela (PGI) through Provincial Social Welfare and Development Office (PSWDO) and Local Government Unit (LGU) through Municipal Social Welfare and Development Office (MSWDO) and some NGO who are generously and willing to give inkind/materials for the safety and protection of the client. While the family counterpart is more on labor and the lot where the house to be built.



III. Other significant information in compliance to level II standard:

- Construction of Annex area for laundry and dirty kitchen of TibayBahay.
- Constructed 3 outdoor bench and tables around area of the WCPC.
- Cemented open space near the kitchen for expansion of laundry area (main building)
- Repair of ceiling in the living area and office.
- Hired contractual resident Nurse.

IV. Problems encountered

- Gate and fence of the center need to be replaced.
- Door and door jambs were infected by termites.
- Absence of other source of water supply for augmentation or back up, especially during weekend and national disaster.
- No standby vehicle to be utilized during emergency cases (check-up of sick residents, court hearings and marketing)


- Request for the increase of budget allocation for food supplies expenses


