Regional Council for the Welfare of Children (RCWC) 3rd Quarter Meeting

SWO III Charmiya Rosalina L. Cruz attended the Regional Council for the Welfare of Children (RCWC) 3rd Quarter Meeting at the DepEd Regional Conference Hall, Carig, Tuguegarao City on August 19, 2014 with the following salient informations, issues and concerns:

1. Updates on the compliance of schools to Child Protection activities and advocacies (Atty. Josemarie Macarilay-Legal Officer, DepEd Reg 02)

All public and private schools is mandated to form or create Child Protection Committees

- ✓ as of August 2014, Isabela province has 334 Children Protection Committees in Elementary while data in secondary level is still due for consolidation
 - ✓ the issue on “corporal punishment” was also raised wherein despite of the strict policy, the DepEd regional office is still receiving reports which are now on review process prior to filing in the court
 - ✓ the DepEd in the region is continuously conducting Capability Building relative to child protection for parents and teachers
 - ✓ the 1st batch of the training was done in Isabela in September 2013
2. Alternative Learning System (ALS) – (Dr. Estelito Balatan - DepEd Reg 02)
 - ✓ Isabela has the highest number of ALS enrollees as well as coordinators in the region
 - ✓ DSWD is the closest partner of DepEd in the implementation of ALS program
 - ✓ Most of the ALS seminars are conducted at the barangay hall
 - ✓ BRO Scholarship program in Isabela has a great number of beneficiaries with the goal to have all Isabeleño children the access to education
 3. BCPC Functionality (Ms. Genevieve Calimag – DILG Reg 02)
 - ✓ Indicators on how to assess the level of functionality of B/C/MCPC was discussed
 - ✓ the council at the Municipal and Provincial Level to conduct regular monitoring to be led by DILG
 4. Updates on Child Friendly Local Governance Audit
 - ✓ The CFLGA evaluation for province of Isabela was done in initial areas namely;
 - Cauayan City
 - Ilagan City
 - Burgos
 - Roxas

 - San Mateo
 - Alicia
- ✓ The 8 areas visited are the areas with an average score of 85% and above as per result of the CFLGA assessment tool, however, it was recommended that all LGU's must undergo assessment in order to meet the requirements for a positive implementation of a Good Local Governance
5. Board of Claims (Atty. Aurora Danao - City Prosecution Office DOJ R02)
- ✓ RA 7309 was discussed
 - DSWD and PNP have the authority to receive claim to clients through legal procedure
 - Beneficiaries of the claim are those who were unjustly accused or unjustly detained
 - Victims of violent crimes
 - 1 year imprisonment is equivalent to one thousand pesos (1,000.00)
 - Where/When/How to file the case
 - Resolution of claim is no days
 - Funding is through the DOJ's Victim Compensation Fund(VCF)
6. Pantawid Pamilya Pilipino Program (Ms. Beneracion F. Cristobal-Regional Beneficiary Data Officer)
- ✓ Pantawid Pamilya beneficiaries of education to finish High School is now approved
 - ✓ higher grant to education beneficiaries from P300.00 to P500.00
 - ✓ P300.00/ child in Elementary
 - ✓ P500.00 / child in High School/ ALS/ ADM
 - ✓ Pilot areas for Set I – San Mariano, Divilacan
7. 2014 Children's Month Celebration (Ms. Lucy Alan – DSWD F02)
- ✓ Representative from Media was requested to air on Radio including possibility of local television access all activities relative to the Children's Month Celebration especially the culminating program at the regional level

The Provincial Model Day Care Center of the provincial government was recommended to serve as the showcase day care center in Region 02 and recognize as the most equipped day care center in terms of the accreditation standards provided under the DSWD Administrative Order No. 16 series of 2011.

Orientation Training on the DepEd – DSWD School-based Feeding Program (SBFP)

AA I/CO I Irene A. Pascua attended Orientation Training on School-Based Feeding Program (SBFP) held at DepEd conference Hall, Alibagu, City of Ilagan, Isabela last August 19, 2014.

The Department of Social Welfare and Development (DSWD) and Department of Education (DepEd) signed a Memorandum of Agreement (to implement the SBFP that will benefit the severely wasted Kinder and Grades I-VI pupils and their families. The DSWD is responsible in releasing funds to the DepEd and shall also help in the monitoring of fund management, utilization, program implementation and respond to operational concerns of the SBFP. The SBFP consist of providing food in addition to the regular meals of severely wasted school children to address the under nutrition problem and short term provision with complete 120 days provision of hot meals to be served once a day for five (5) days a week. Parents of beneficiaries will managed the feeding program based on a prepared meal cycle using available indigenous food supplies.

The one day orientation was participated by school heads/principals, H.E. Head teachers, school nurses and bid coordinators from Area I.

CLIP Meeting was conducted on August 27, 2014

The Comprehensive Local Integration Program (CLIP) Meeting was conducted to finalize the composition of the Committee as required pursuant to DILG – OPAPP joint Memorandum Circular No 2014 -01 dated May 15, 2014 where the Governor is the Chairman and as to its membership, it was suggested by Col. Labanen be made positional without naming the incumbent head of the agency, office o organization considering the duty of the Police Chief Superintendents and Commanding Officer of the military. The group was unanimous in recommending such presentation. The committee agreed to come up initially with a draft Implementation Plan on September 1, 2014 1:00 PM that would be responsive to the consolidated needs of the FR's.
