D. PERSONNEL STAFFING

As of October 2024, there are One Hundred Five (105) Plantilla Positions, wherein seventy-nine (79) personnel are with permanent positions. At present, there are 6 Permanent Physicians and 2 Contractual Physicians, 1 Permanent Radiologist Doctor, 8 Private Doctors and 4 Doctors from DOH with different specialties serving the hospital under Memorandum of Agreement with the Provincial Government of Isabela. In the Nursing Service, there are 27 Permanent Nurses, 15 Contractual Nurses, 8 Permanent Nursing Attendants, 9 Contractual Nursing Attendants and 1 Permanent Midwife. In the Ancillary Services, 1 Permanent Dentist, 3 Permanent Med. Tech., 8 Contractual Med. Tech., 1 Permanent Lab. Aide., 1 Permanent Rad. Tech., 2 Permanent MET, 6 Contractual Rad. Tech., 2 Permanent Pharmacists, 4 Contractual Pharmacists and 1 Contractual Pharmacy Aide. In Administrative Services, 24 permanent employees and 31 contractual employees.
