A RESOLUTION DECLARING ORDINANCE NO. 24-2018 (SUPPLEMENTAL BUDGET NO. 03-2018) IN THE AMOUNT OF ELEVEN MILLION FORTY SEVEN THOUSAND TWO HUNDRED FIFTY SIX PESOS & 80/100 (P11,047,256.80) OF THE MUNICIPALITY OF RAMON, ISABELA **OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS**

WHEREAS, Ordinance No. 24-2018, an Ordinance appropriating Supplemental Budget No. 03-2018 in the amount of ELEVEN MILLION FORTY SEVEN THOUSAND TWO HUNDRED FIFTY SIX PESOS & 80/100 (P11,047,256.80) for Economic Relief Assistance (goods) to indigent constituents, Capital Outlay, 5% Gender & Development Fund (GAD) and 5% Local Disaster Risk Reduction and Management Fund (LDRRMF), was submitted to this Sanggunian for review pursuant to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of HON. DELFINITO EMMANUEL L. ALBANO duly seconded:

RESOLVED, to declare Appropriation Ordinance No. 24-2018 of the Municipality of Ramon, Isabela OPERATIVE IN ITS ENTIRETY subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

A RESOLUTION DECLARING ORDINANCE NO. 24-2018 (SUPPLEMENTAL BUDGET NO. 03-2018) IN THE AMOUNT OF ELEVEN MILLION FORTY SEVEN THOUSAND TWO HUNDRED FIFTY SIX PESOS & 80/100 (P11,047,256.80) OF THE MUNICIPALITY OF RAMON, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

- That the amount for Economic Relief Assistance (ERA) of Nine Million Four Hundred Forty Two Thousand Five Hundred Thirty One Pesos & 12/100 (9,442,531.12) donated to indigent constituents of the Local Government of Ramon, Isabela, must be covered with appropriate guidelines and legal basis for its grant;
- 2. The utilization for the appropriation of Capital Outlay in the amount of Five Hundred Thousand Pesos (P500,000.00) shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations;
- 3. The appropriation for Gender and Development (GAD) in the amount of Five Hundred Fifty Two Thousand Three Hundred Sixty Two Pesos & 84/100 (P552,362.84) shall be in accordance with DBM-NEDA-NCFRW Joint Circular No. 2004-1 dated April 5, 2014, and PCW-NEDA-DBM Joint Memorandum Circular No. 2014-01. A copy of the GAD Plan endorsed by the DILG should be furnished to this office;
- 4. The appropriation and utilization of the LDRRMF in the amount of Five Hundred Fifty Two Thousand Three Hundred Sixty Two Pesos & 84/100 (P552,362.84) shall adhere to the provisions of Republic Act 10121, DILG Memorandum Circular No. 2012-73 dated April 17, 2012 and NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013;

RESOLVED FURTHER, to require the Municipality of Ramon, Isabela to comply with the herein condition;

RESOLVED FURTHERMORE, to inform the Municipality of Ramon, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations;

RESOLVED FINALLY, to furnish a copy of this Resolution to the Sangguniang Bayan of the Municipality of Ramon, Isabela through the **Honorable JESUS D. LADDARAN**, Municipal Mayor.
