- 3. The appropriation for Capital Outlay in the amount of Four Hundred Ninety Seven Thousand Eight Hundred Sixty Eight Pesos & 50/100 (P497,868.50) must be governed by the provisions of republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations;

RESOLVED FURTHER, to inform the Municipality of Jones, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
