ALBANO III TO ENTER IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE LOCAL GOVERNMENT OF MALLIG AND MALAYA DEVELOPMENT COOPERATIVE FOR THE ASSUMPTION OF MANAGEMENT AND OPERATIONS OF ISABELA DAIRY ENTERPRISE

WHEREAS, in conformity with the above policy the Provincial Government of Isabela must encourage, promote and protect cooperative ventures;

WHEREAS, to improve and amplify the agricultural production of the Province as well as to provide employment and economic opportunities to Isabeleños, the Provincial Governor desires to enter into a Memorandum of Agreement with the Local Government Unit of Mallig, Isabela and Malaya Development Cooperative;

WHEREAS, the Memorandum of Agreement provides for the temporary transfer of management and operation of Isabela Dairy Enterprise to LGU Mallig and Provincial Government of Isabela in view of the financial and operational inability of Malaya Development Cooperative and shall take over the same until fully rehabilitated;

**WHEREAS,** it is to best interest of the Province to confer the Provincial Governor the necessary authority to sign the Memorandum of Agreement;

NOW THERFORE, upon unanimous accord of the Body, be it -

RESOLVED, AS IT HEREBY RESOLVES: TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III TO ENTER IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE LOCAL GOVERNMENT OF MALLIG AND MALAYA DEVELOPMENT COOPERATIVE;
