WHEREAS, for this reason, the PGI seeks to contract Safewaste Incorporated, a duly registered and accredited corporation engaged in the business of handling and processing toxic, hazardous, and infectious wastes;

WHEREAS, this Body deems it beneficial and advantageous to the Province to grant the Provincial Governor the necessary authority to sign the MOA in behalf of the PGI;
