A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A MEMORANDUM OF AGREEMENT WITH AMKA TRADING ALLOWING THE LATTER TO INSTALL AND OPERATE ITS DIAGNOSTIC EQUIPMENTS IN THE HOSPITALS OWNED AND OPERATED BY THE PGI

WHEREAS, the PGI acknowledges the importance of establishing strong partnerships and mutually-beneficial relations with the private sector to facilitate the achievement of its desired programs and services for its constituents;

WHEREAS, AMKA Trading (AMKA), a local distributor of medical equipments and laboratory supplies, offered its services to the PGI for the installation and operation of its diagnostic equipments in the hospitals owned and operated by the PGI with the condition that the PGI shall purchase the reagents of AMKA and will not install competing or similar equipments in its hospitals where AMKA equipments are installed;

WHEREAS, the MOA also provides that ownership of the AMKA diagnostic equipments will be transferred to the PGI after five years;

WHEREAS, this Body deems the agreement beneficial and advantageous to the Province, and hereby concurs to provide the Provincial Governor the necessary authority to sign the MOA in behalf of the PGI;

WHEREFORE, upon motion of the Hon. Emmanuel Joselito B. Añes, duly approved and seconded by all the members present in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES: TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
