A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HON. RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT FOR THE IMPLEMENTATION OF THE TUPAD WORKERS PROGRAM

WHEREAS, TUPAD Workers Program is a community based assistance that provides emergency employment for displaced workers, underemployed and seasonal workers, for a minimum period of 10 days, but not to exceed a maximum of 30 days, depending on the nature of work to be performed;

WHEREAS, the Provincial Government of Isabela recognizes the importance of providing immediate assistance to Isabeleños in times of natural disasters, calamities, occurrence of armed conflicts or the displacement of workers with the closure or slowing down of operations of companies as a result of economic disruptions;

WHEREFORE, premises considered, upon motion of Hon. Adrian Philip S. Baysac, duly approved and seconded by all members in a session duly assembled, it was-
