A RESOLUTION URGING THE NATIONAL FOOD AUTHORITY TO PURCHASE PALAY FROM LOCAL RICE FARMERS, AS ORDERED BY

PRESIDENT RODRIGO R. DUTERTE

WHEREAS, to protect rice farmers and the local rice industry from the adverse effects of the Rice Tarrification Law, the State assured assistance to farmers and the development of the rice industry from the collected rice tariffs;

WHEREAS, this assurance has not prevented local rice farmers from experiencing profit losses as they now struggle to make ends meet with farm gate price for palay hitting record lows;

WHEREAS, local rice farmers have expressed their concerns and grievances regarding their profit losses due to the influx of and competition with cheap, imported rice;

WHEREAS, there is now a glaring need to provide immediate and effective assistance to our local rice farmers, and the same was acknowledged by President Rodrigo R. Duterte who ordered the National Food Authority to purchase palay from local farmers;

WHEREAS, in line with the foregoing, this Body respectfully forwards its request to the National Food Authority to provide assistance to our farmers by purchasing their palay;

**WHEREFORE**, upon motion of Hon. Adrian Philip S. Baysac duly approved and seconded by all of the members present in a session duly assembled it was –

RESOLVED AS IT IS HEREBY RESOLVES:TO ADOPT A RESOLUTION URGING THE NATIONAL FOOD AUTHORITY TO PURCHASE PALAY FROM LOCAL RICE FARMERS, AS ORDERED BY PRESIDENT RODRIGO R. DUTERTE
