WHEREAS, as of December 2018 the Province of Isabela has 605 registered cooperatives and among the 34 municipalities, 2 cities and 1 independent city only 2 municipalities and 3 cities has full – pledged Municipal/City Cooperative Development Officer;

WHEREAS, the Department of Interior and Local Government (DILG) and Cooperative Development Authority (CDA) issued Joint Memorandum Circular No. 2019 – 01 whereby it enjoins all Local Government Units through the Local Chief Executives to perform powers and functions for the promotion, organization, and development of cooperatives;
