A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HON. RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A DEED OF USUFRUCT WITH PHILIPPINE NATIONAL RED CROSS — ISABELA CHAPTER OVER A PGI PROPERTY LOCATED IN OLD CAPITOL BUILDING, ILAGAN CITY, ISABELA

WHEREAS, the PGI seeks to further emphasize its support to the endeavors and policies of the PNRC by providing its local component, PNRC – Isabela Chapter, premises to which they can operate and execute their objectives;

WHEREAS, the Provincial Government of Isabela has offered the PNRC – Isabela Chapter the right to use a six hundred thirty four (634) square – meter – portion of a parcel of land, registered under its name, located at the Old Capitol Compound, Alibagu, City of Ilagan, Isabela;

WHEREAS, providing PNRC – Isabela Chapter the right to use the said property necessitates the execution of a Deed of Usufruct, which further entails the grant of authority from the Sanggunian before the PGI can validly enter into the same;

WHEREAS, this Body, after careful consideration and perusal of the Deed of Usufruct, resolved that the grant of authority is beneficial to the PGI and desirable in furthering its health and medical assistance policies to Isabeleños;

WHEREFORE, upon motion of Honorable Marco Paolo A. Meris duly approved and seconded of all the members in a session duly assembled it was –
