WHEREAS, it is the policy of the Provincial Government of Isabela to provide Isabeleños with effective medical care and services, and adequate medical facilities;

ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT AND GOVERNOR FAUSTINO N. DY SR. MEMORIAL HOSPITAL FOR THE IMPLEMENTATION OF THE DOH – MEDICAL ASSISTANCE PROGRAM IN THE PROVINCE OF ISABELA

WHEREAS, the National Government established the MAP to provide medical assistance to indigent patients seeking consultation, rehabilitation, examination or otherwise confined in government hospitals;

WHEREAS, the said MOA impels the DOH – CVCHD, pursuant to the MAP, to transfer funds in favor of the PGI in the initial seed capital amount of Nine Hundred Ninety Thousand Pesos (Php990,000.00) and to make succeeding monetary transfers, subject to the condition that the PGI has liquidated at least fifty percent (50%) of the previously downloaded funds in accordance with pertinent budgeting and auditing rules and regulations;

WHEREAS, it is for the best interest of the PGI and the Isabeleños to provide the Provincial Governor the necessary authority to sign the MOA;

WHEREFORE, premises considered, the Sanggunian resolves, as it hereby resolves to enact a -
