RODOLFO T. ALBANO III, TO EXERCISE HIS AUTHORITY TO TRANSACT AND NEGOTIATE WITH THE LBP FOR SUCH PURPOSE

WHEREAS, the Provincial Government of Isabela, in the exercise of its corporate powers, is empowered to enter into contracts and exercise such other powers as granted to corporations subject to the limitations provided under the Local Government Code and other applicable laws;

WHEREAS, there exists an extreme and urgent necessity to provide small and other marginalized farmers with additional economic assistance considering the financial distress that they are currently experiencing with the rapid decrease of palay gate prices;

WHEREAS, the Provincial Government has identified a property in San Agustin Road, Barangay Ipil, Echague, Isabela, owned by Land Bank of the Philippines, to be strategically advantageous and desirable to promote such aspiration of the Province;

WHEREAS, this Body is earnestly urging the Provincial Governor, Hon. Rodolfo T. Albano III, to exercise his authority by transacting and negotiating with the Land Bank of the Philippines for the execution of a Contract of Lease over their aforesaid property to serve as a storage house for the sacks of palay grown and produced by the local rice farmers

WHEREFORE, upon motion of the **Hon. Marco Paolo A. Meris** duly seconded and approved of all the members present in a session duly assembled it was –
