WHEREAS, it is the policy of the State to advance the local food production industry and to provide ample support in the pursuit of achieving innovations and the development thereof for the realization of its ultimate goal of achieving food security in the country;

WHEREAS, the Department of Agriculture is the government agency primarily responsible for the promotion of agricultural development by providing framework, public investments, and support services;

WHEREAS, the Department of Agriculture devised the National Quality Corn Achievers Award in recognition to cities, municipalities, and provinces for their outstanding performance towards the production of quality corn and the development of the corn industry;

WHEREAS, the Provincial Government of Isabela was conferred with the 2019 National Quality Corn Achievers Award in which, aside from the distinctive recognition it received, was rewarded with funds in the amount of Three Million Pesos (Php3,000,000.00);

WHEREAS, the Provincial Government of Isabela aspires to utilize the whole sum of the reward it received from winning the 2019 National Quality Corn Achievers Award for the purchase of two (2) units of motor vehicles which, as per the Office of the Provincial Agriculturist, will be utilized in facilitating local food production and further developing the local agricultural industry;

WHEREAS, the Department of Interior and Local Government requires Sanggunians to adopt a Resolution granting their Local Chief Executives with appropriate authority to utilize monetary rewards from the National Quality Corn Achievers Award;

WHEREAS, this Honorable Body finds it beneficial and advantageous to the Isabeleño populace to grant the Provincial Governor, Honorable Rodolfo T. Albano III, appropriate and ample authority to utilize the whole sum rewarded by the Department of Agriculture to the Provincial Government of Isabela for winning the 2019 National Quality Corn Achievers Award for the purchase of two (2) units of motor vehicle;

RESOLVED FINALLY, to furnish the Provincial Governor, Honorable Rodolfo T. Albano III, a copy of this Resolution for his information and further action.


