WHEREAS, the world is facing an unprecedented international health crisis due to the rapid spread of the deadly Corona Virus Disease (COVID-19) which affected countless lives and halted economies all while claiming thousands of casualties on a daily basis;

WHEREAS, on March 16, 2020, His Excellency, President Rodrigo R. Duterte, issued Presidential Proclamation No. 922, series of 2020, which placed the Philippines under a State of Public Health Emergency due to the increasing number of COVID-19 cases in the country;

WHEREAS, on March 17, 2020, President Rodrigo R. Duterte issued Presidential Proclamation No. 929, series of 2020, further placing the entire country under State of Calamity and imposed an Enhanced Community Quarantine throughout Luzon to address the local spread of COVID-19;

WHEREAS, DILG Memorandum Circular No. 2020-062 titled "Suppletory LGU Guidelines on the Implementation of the Enhanced Community Quarantine in Luzon, and State of Public Health Emergency in Other Parts of the Country due to COVID-19" ordered all LGUs "to take the lead in the prevention and control of the spread of COVID-19 at the local level";

WHEREAS, this Honorable Body lauds the strong, decisive efforts exhibited by all local government units and their officials in implementing effective courses of action to prevent the spread of COVID-19 in the Province;

WHEREAS, to further ensure that no local community transmission will occur and that the sacrifices of our people, especially our medical frontliners, will not be wasted, we need to amplify our efforts and strengthen our campaign against COVID-19;

WHEREAS, equipping the public with proper information relative to the nature and effects of COVID-19 remains as the most effective way to topple the virus. As such, the citizenry must be advised and re-enlightened of the personal protective and community preventive measures against COVID-19, such as, but not limited to:

- Frequent Proper Handwashing and use of Rubbing Alcohols or Hand Sanitizers with at least 70% Alcohol concentration;
- Maintain good overall hygiene;
- · Habitual Wearing of Face Masks;
- Strict observance of Physical Distancing, especially in crowded places; and
- Achieve Optimum Immune Health by taking proper food, medicine, and performing physical exercises.

WHEREAS, this Honorable Body advises local government units to make use of mobile sound systems to promote speedy dissemination of information and prevent possible disease transmissions;

WHEREFORE, premises considered, upon motion of Hon. Emmanuel Joselito B. Añes, duly seconded and approved in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT A RESOLUTION ENJOINING ALL LOCAL GOVERNMENT UNITS TO RECONDUCT PUBLIC INFORMATION DRIVES RELATIVE TO PERSONAL PROTECTIVE AND COMMUNITY PREVENTIVE MEASURES AGAINST COVID-19;
