ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE NO. 02, DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT REGIONAL OFFICE NO. 02, STATE UNIVERSITIES AND COLLEGES IN REGION II, AND PROVINCIAL LOCAL GOVERNMENT UNITS OF REGION II FOR THE ESTABLISHMENT OF A COORDINATED ANTI-FALL ARMYWORM RESPONSE AND CONTROL MECHANISM IN REGION II

WHEREAS, the avertion of such outbreaks necessitates a coordinated and collaborative response between concerned departments of the National Government, Local Government Units, and State Universities and Colleges;

WHEREAS, the Department of Agriculture Regional Field Office No. 02 (DA RF02), Department of Interior and Local Government Regional Office No. 02 (DILG 02), State Universities and Colleges in Region II (SUCs), and Provincial Local Government Units of Region II (PLGUs) collectively expressed their commitment to establish a Region-wide anti-fall armyworm response and control mechanism in Region II;

WHEREAS, to effectuate their commitment and in furtherance of their mutual goal to protect and promote the welfare of the citizens of Region II, the aforesaid entities resolved to execute a Memorandum of Agreement;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body confers upon the Provincial Governor, Honorable Rodolfo T. Albano III, the requisite authority to sign in behalf of the Provincial Government of Isabela the MOA with DA RF02, DILG 02, SUCs, and PLGUs in Region II;

WHEREFORE, premises considered, upon motion of Hon. Adrian Philip S. Baysac, duly approved and seconded in a Session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
