WHEREAS, the Department of Health (DOH), through the DOH – Cagayan Valley Center for Health Development (DOH-CVCHD), aspires to repair, upgrade, improve, and expand the Milagros Albano District Hospital, Manuel A. Roxas District Hospital, and Cauayan District Hospital through the Health Facilities Enhancement Program. To achieve this, the DOH has appropriated the amount of Php5,910,000.00;

WHEREAS, the endeavor of the Department of Health to enhance the medical capability and capacity of the Milagros Albano District Hospital, Manuel A. Roxas District Hospital, and Cauayan District Hospital requires the execution of a Memorandum of Agreement (MOA) between the DOH-CVCHD and the Provincial Government of Isabela (PGI);

WHEREAS, the Office of the Provincial Governor submitted a Letter before this Honorable Body requesting that the Provincial Governor be granted with authority to sign a MOA on behalf of the PGI for the implementation of DOH's Health Facilities Enhancement Program in the Province of Isabela;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body determined that the proposed MOA to be executed by the PGI and DOH-CVCHD for the implementation of DOH's Health Facilities Enhancement Program in the Province of Isabela to be beneficial and advantageous to Isabeleños;

WHEREFORE, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was —
