WHEREAS, on November 12, 2020, Typhoon Ulysses hit the country and left extensive destruction and damage in Luzon;

WHEREAS, due to heavy rains brought about by Typhoon Ulysses, Magat Dam was forced to release water which caused the abrupt increase of water level in Cagayan River and eventually resulted to heavy flooding and temporary displacement of communities not to mention huge damage to crops and properties;

A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO DISBURSE THE AMOUNT OF FORTY FOUR MILLION FIVE HUNDRED SIXTY ONE THOUSAND SEVEN HUNDRED TWELVE PESOS (Php 44, 561,712.00) FROM THE TRUST FUND TO COVER FUNDING REQUIREMENTS FOR FINANCIAL ASSISTANCE TO LGUS AFFECTED BY TYPHOON ULYSSES

WHEREAS, Special Provision No. 1 (a) of the NDRRM Fund under the FY 2020 GAA, RA No. 11465 allocated funds for relief, recovery, reconstruction and other works or services in connection with natural or human-induced calamities which may occur during the current year, or those that occurred in the two (2) preceding years, subject to approval of the President of the Philippines who may take into consideration the recommendation of the NDRRM Council for local disasters or the appropriate agency for international crises.

WHEREAS, to immediately extend assistance to displaced communities affected by typhoon, the national government downloaded funds from the Regular Agency Fund, FY 2020 GAA, RA 11465 National Disaster Risk Reduction and Management Fund (Calamity Fund) in the amount of Forty Four Million Five Hundred Sixty One Thousand Seven Hundred Twelve Pesos (Php 44, 561,712.00) to the Provincial Government of Isabela:

WHEREAS, presented for consideration is the request seeking authority to utilize the said funds for the purchase of food and non-food items for distribution to LGUs affected by Typhoon Ulysses;

WHEREAS, this Honorable Body deemed it necessary to act on the request and extend assistance to communities affected by Typhoon Ulysses;

WHEREFORE, premises considered, upon motion of Hon. Alfredo V. Alili, duly approved and seconded in a session duly assembled, it was-
