WHEREAS, the levying of taxes, fees, and charges are constitutionally recognized as a necessary component for the proper and continuous function of the government, to fund its various programs, initiatives, and services for the benefit and protection of the people;

WHEREAS, the Local Government Code empowers Local Government Units to create their own sources of revenue, and to levy taxes, fees, and charges subject to the limitations provided by law;

WHEREAS, Section 139 of the Local Government Code authorizes Province and City Government Units to "levy an annual professional tax on each person engaged in the exercise or practice of his profession requiring government examination..."

WHEREAS, paragraph d of the above cited provision mandates professionals who practice their profession to pay professional taxes on or before 31st of January, unless the professional began to practice his or her profession after such period to which the professional shall be liable to pay professional taxes before engaging therein;

WHEREAS, the Province calls the assistance and support of its citizens liable for the payment of professional taxes to observe their legal accountabilities and assist the Provincial Government of Isabela in sustaining its efforts in ensuring and furthering the welfare of each Isabeleño;

WHEREAS, the cooperation of institutions employing professionals are also earnestly sought to remind their professional employees to pay professional taxes;

WHEREFORE, premises considered, upon motion of Hon. Alfredo V. Alili, duly approved and seconded in a motion duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT: A RESOLUTION URGING ALL PROFESSIONALS IN THE PROVINCE OF ISABELA TO PAY THEIR PROFESSIONAL TAXES
