A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 02 S. 2019 (SUPPLEMENTAL BUDGET NO. 01 FY 2019) IN THE AMOUNT OF ONE MILLION TWENTY FIVE THOUSAND FOUR HUNDRED TWENTY ONE PESOS & 80/100 (P1,025,421.80) OF THE MUNICIPALITY OF QUIRINO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 02 S. 2019 of the Municipality of Quirino, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- The grant of Year End Bonus and Cash Gift in the amount of One Hundred Forty Four Thousand Two Hundred Eighty Five Pesos (P144,285.00) and Sixty Thousand Pesos (P60,000.00) respectively, shall be in accordance with the guidelines of DBM Budget Circular No. 2016-4 dated April 28, 2016 on the Updated Rules and Regulations on the Grant of Year-End Bonus and Cash Gift for FY 2016 and Years Thereafter;
- The grant of Other Personnel Benefits Productivity Enhancement Incentive (PEI) in the amount of Sixty Thousand Pesos (P60,000.00) shall be in accordance with DBM Budget Circular No. 2017-4 dated December 4, 2017, on the Guidelines on the Grant of the Productivity Enhancement Incentive (PEI) to Government Employees for FY 2017 and Years Thereafter;

RESOLVED FURTHER, to require the Municipality of Quirino, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Quirino Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the Sangguniang Bayan of the Municipality of Quirino, Isabela through the **Honorable EDWARD D. JUAN**, **Municipal Mayor**.
