WHEREAS, the Philippines is experiencing an unprecedented health crisis due to the spread and pervasiveness of COVID-19;

WHEREAS, the Provincial Government of Isabela (PGI) fully adheres to the guidelines, protocols, and regulations of the National Government relative to the containment and resolution of the COVID-19 crisis;

WHEREAS, in support and in furtherance of such guidelines, protocols, and regulations, the PGI has partnered with the private sector and public academic institutions in the establishment of quarantine facilities for probable and suspected cases of COVID-19;

WHEREAS, the Province of Isabela is currently experiencing a steady resurgence of COVID-19 cases, in which, as of June 22, 2020, it has recorded eight (8) active cases;

A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A CONTRACT OF LEASE WITH MS. MARY GRACE SALACUP DONATO FOR THE UTILIZATION OF ORIENT PEARL DRIVE-INN HOTEL AS A QUARANTINE FACILITY FOR PROBABLE AND SUSPECTED CASES OF COVID-19

WHEREAS, there is an expected increase of probable and suspected COVID-19 cases in the Province as our health and government officials conduct contact tracing of those who had primary, secondary, and tertiary contact with the confirmed cases;

WHEREAS, there is a clear necessity to establish additional quarantine facilities in preparation for the expected increase of probable and suspected COVID-19 cases and for their prompt isolation from the populace;

WHEREAS, the PGI and Orient Pearl Drive-Inn Hotel, owned by Ms. Mary Grace Salacup Donato, seeks to forge a partnership thru a Lease Agreement, for the utilization of the latter's premises as a quarantine facility for COVID-19 suspects and probable cases;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body confers upon the Provincial Governor, Honorable Rodolfo T. Albano III, the requisite authority to sign in behalf of the PGI a Contract of Lease with Ms. Mary Grace Salacup Donato for the utilization of Orient Pearl Drive-Inn Hotel as a quarantine facility for COVID-19 suspects and probable cases;

WHEREFORE, premises considered, upon motion of Hon. Marco Paolo A. Meris, duly approved and seconded in a session duly assembled it was —

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A CONTRACT OF LEASE WITH MS. MARY GRACE SALACUP DONATO FOR THE UTILIZATION OF ORIENT PEARL DRIVEINN HOTEL AS A QUARANTINE FACILITY FOR PROBABLE AND SUSPECTED CASES OF COVID-19;
