NOW THEREFORE, on motion of SP Member DELFINITO EMMANUEL L. ALBANO duly seconded:

#### THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 06-2019 of the Municipality of Burgos, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The utilization of the appropriation for Terminal Leave and Monetization of Leave Credits in the amount of Two Hundred Ninety Eight Thousand One Hundred Seventy Pesos & 98/100 (P298,170.98) and One Hundred Seven Thousand Five Hundred Sixty Two Pesos & 25/100 (P107,562.25) respectively, shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016 on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on the Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
- The payment of Travelling Allowance in the amount of Twenty Five Thousand Five Hundred Pesos (P25,500.00) shall be in accordance with the guidelines of Local Budget Circular No. 103 dated May 15, 2013, on the Amended Rules and Regulations on the Grant of Representation and Transportation Allowance;
- The appropriation for Gender and Development (GAD) in the amount of One Hundred Fifty Thousand Pesos (P150,000.00) shall be in accordance with DBM-NEDA-NCFRW Joint Circular No. 2004-1 and PCW-NEDA-DBM Joint Memorandum Circular No. 2014-01, dated April 5, 2014;

**RESOLVED FURTHER**, to require the Municipality of Burgos, Isabela to comply with the herein review findings and/or conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Burgos, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the Sangguniang Bayan of the Municipality of Burgos, Isabela through the **Honorable KERVIN FRANCIS G. UY**, Municipal Mayor.
