A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) ALL CONTRACTS OF LEASE RELATIVE TO THE RENTAL OF STALL UNITS AND COMMERCIAL FACILITIES OWNED BY THE PGI, EFFECTIVE UNTIL JULY 31, 2021

WHEREAS, the Local Government Code (LGC) empowers local government units to create their own sources of revenue;

WHEREAS, the LGC, particularly Section 468(2)(v) thereof, encourages local government units to generate and maximize the use of its resources and revenues, which include the option of leasing government properties to private parties, subject to existing laws, rules, and regulations;

WHEREAS, the PGI owns several properties which it holds for proprietary and commercial purposes, such as those located near its District Hospitals and in the Provincial Capitol Compound which are made available for rentals as stores, canteens, and market stalls;

WHEREAS, Section 465(I)(vi) of the LGC empowers the Provincial Governor to represent the Provincial Government in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Alfredo V. Alili, duly approved and seconded in a session duly assembled it was –
