WHEREAS, the Municipal Government of San Mariano, Isabela of San Mariano, Isabela passed Resolution No. 2020-023 which expressed their earnest request to the Honorable Provincial Governor, Honorable Rodolfo T. Albano III, to cause the transfer without cost of a certain property owned by the Provincial Government of Isabela, covered by TCT-T-387687, in favor of the Municipal Government of San Mariano, Isabela which they intend to utilize as site for the construction of a new Isabela Provincial Hospital;

WHEREAS, the Office of the Provincial Governor endorsed to this Honorable Body the said Resolution of the Municipal Government of San Mariano, Isabela of San Mariano, Isabela, and also made his request for the grant of authority to effectuate such transfer without cause in their favor;

WHEREAS, this Honorable Body interposes no objection to the request of the Honorable Provincial Governor as the transfer without cost of the said PGI property in favor of the Municipal Government of San Mariano, Isabela is in furtherance of our goal to promote the health and general welfare of our people;

WHEREAS, to effectuate the transfer without cost of the herein mentioned PGI property, a Deed of Donation must be executed between the Provincial Government of Isabela and the Municipal Government of San Mariano, Isabela;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Marco Paolo A. Meris, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF DONATION CONVEYING A PARCEL OF LAND COVERED BY TCT-T-387687 IN FAVOR OF THE MUNICIPAL GOVERNMENT OF SAN MARIANO, ISABELA

RESOLVED FURTHER, that this gratuitous conveyance in favor of the Municipal Government of Isabela shall be conditioned on the fact that the donated lot shall be utilized as the site of the new Isabela Provincial Hospital.
