WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular No. 122 which provides for the Guidelines on the Release and Utilization of the Local Government Support Fund — Other Financial Assistance to Local Government Units (LGSF-FA to LGUs) in the FY 2020 General Appropriations Act (GAA), Republic Act No. 11465);

**WHEREAS**, the acquisition of mini dump truck is one of the enumerated priority programs and projects which are eligible to be funded under the Local Government Support Fund – Other Financial Assistance to Local Government Units (LGSF-FA to LGUs);

**WHEREFORE**, premises considered, upon motion of HON. ALFREDO V. ALILI, duly seconded and unanimously approved by the members of this August Body, it was-
