WHEREAS, to advance its disaster preparedness goals, there is a need to purchase additional units of dump trucks to be utilized in times of disasters or calamities as well as for implementation of infrastructure projects;

WHEREAS, despite being included in the Local Development Investment Program and Annual Investment Program as one of its priority projects, it is constrained by inadequate funds to purchase new dump trucks to be distributed in the different municipalities and cities in the province;

WHEREAS, there is need to ask for financial assistance from the LPG Marketers Association Represented by HON. ALLAN U. TY through the Local Government Support Fund – Other Financial Assistance to Local Government Units (LGSF-FA to LGUs);

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular No. 122 which provides for the Guidelines on the Release and Utilization of the Local Government Support Fund — Other Financial Assistance to Local Government Units (LGSF-FA to LGUs) in the FY 2020 General Appropriations Act (GAA), Republic Act No. 11465:

**WHEREAS**, the acquisition of mini dump truck is one of the enumerated priority programs and projects which are eligible to be funded under the Local Government Support Fund — Other Financial Assistance to Local Government Units (LGSF-FA to LGUs);

WHEREFORE, premises considered, upon motion of HON. ALFREDO V. ALILI, duly seconded and unanimously approved by the members of this August Body, it was-
