A RESOLUTION DECLARING THE PROVINCE OF ISABELA UNDER STATE OF CALAMITY DUE TO THE SPREAD OF THE AFRICAN SWINE FEVER AND 2019 CORONA VIRUS DISEASE

WHEREAS, local government units, through their Sanggunians, have the power to place their respective territories under State of Calamity upon occurrence of incidences as provided by law;

WHEREAS, the Province of Isabela is currently experiencing a major disruption of its local economy and the normal function of its communities due to the rapidly growing and large-scale spread of the African Swine Fever which, as per current data, has affected its thirty-two (32) barangays and fourteen (14) of its municipalities;

WHEREAS, the spread of the African Swine Fever has discouraged the purchase of swine and pork products which immensely affected the livelihood of thousands of hog growers and thousands more whose daily income relies on the meat-selling market;

WHEREAS, the World Health Organization is considering to declare the deadly 2019 Corona Virus Disease as a pandemic with the virus having infected hundreds of thousands globally and new confirmed cases being reported continually;

WHEREAS, on March 8, 2020, His Excellency, President Rodrigo R. Duterte, declared the Philippines under State of Public Health Emergency due to the occurrence of a local transmission of the 2019 Corona Virus Disease in the country;

WHEREAS, as of March 10, 2020, there are thirty-three (33) confirmed cases of the 2019 Corona Virus Disease in the country, with fears that more are infected and are being infected due to the asymptomatic, highly infectious, and easily communicable nature of the virus;

WHEREAS, the simultaneous occurrence of the spread of the African Swine Fever in the Province and the rapidly increasing number of confirmed 2019 Corona Virus Disease cases in the country presents clear and present danger to public health, safety, and security, and have caused immeasurable damage to the Province's economy;

WHEREAS, the Sangguniang Panlalawigan, in response to the dire and alarming situation at hand, must take appropriate and definite action to prevent the degradation of the Province's safety and security, and to ensure the public health and general welfare of Isabeleños;

WHEREAS, by virtue of the powers vested by law, this Sanggunian hereby declares the entire Province of Isabela under State of Calamity;

NOW THEREFORE, premises considered, upon motion of Hon. Emmanuel Joselito B. Añes, the Sangguniang Panlalawigan, in a session duly assembled, unanimously approves to adopt: A RESOLUTION DECLARING THE PROVINCE OF ISABELA UNDER STATE OF CALAMITY DUE TO THE SPREAD OF THE AFRICAN SWINE FEVER AND 2019 CORONA VIRUS DISEASE
