RESOLUTION NO. 2020-10-10 SERIES OF 2020

A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE COMMISSION ON HIGHER EDUCATION AND ISABELA STATE UNIVERSITY FOR THE UTILIZATION OF SELECT PREMISES WITHIN THE CAMPUSES OF ISABELA STATE UNIVERSITY AS QUARANTINE FACILITIES FOR COVID-19 PUIs and PUMS

WHEREAS, on March 12, 2020, the World Health Organization classified the 2019 Corona Virus Disease (COVID-19) as a pandemic with the virus infecting hundreds of thousands globally and killing thousands, with new cases being reported continually;

WHEREAS, on March 16, 2020, His Excellency, President Rodrigo R. Duterte, issued Presidential Proclamation No. 922, series of 2020, which placed the country under a State of Public Health Emergency due to the rising number of COVID-19 cases in the country;

A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE COMMISSION ON HIGHER EDUCATION AND ISABELA STATE UNIVERSITY FOR THE UTILIZATION OF SELECT PREMISES WITHIN THE CAMPUSES OF ISABELA STATE UNIVERSITY AS QUARANTINE FACILITIES FOR COVID-19 PUIS and PUMS

WHEREAS, a day after such Proclamation, President Rodrigo R. Duterte issued Presidential Proclamation No. 929, series of 2020, further placing the entire country under State of Calamity for six (6) months unless earlier lifted or extended as the circumstances may warrant, and imposed an Enhanced Community Quarantine throughout Luzon;

WHEREAS, pursuant to the directive of the President and in fulfillment of its mandate to protect and promote the general welfare of its people, the Provincial Government of Isabela (PGI) immediately established proactive, preventive, and sustainable measures to avert the spread of COVID-19 in the Province;

WHEREAS, in furtherance of the Province's strict anti-COVID-19 measures, the Provincial Government of Isabela has expressed the need to amplify its efforts in preventing the local spread of the disease. Pursuant to this drive, the PGI, thru the Provincial Governor, Hon. Rodolfo T. Albano III, requested the officials of the Commission on Higher Education (CHED) and Isabela State University (ISU) to utilize premises within ISU campuses as quarantine facilities to which COVID-19 PUIs and PUMs will be sheltered in during their quarantine period;

WHEREAS, the utilization of ISU campuses as quarantine facilities will further strengthen the capability of the Provincial Government of Isabela to contain, prevent, and resolve the spread of COVID-19 in the Province of Isabela;

WHEREAS, the officials of CHED and ISU granted the aforesaid request of the Provincial Government of Isabela and have agreed to effectuate the same thru a Memorandum of Agreement;

WHEREFORE, upon motion of Honorable Marco Paolo A. Meris, duly approved and seconded by all the members present in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES: TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE COMMISSION ON HIGHER EDUCATION AND ISABELA STATE UNIVERSITY FOR THE UTILIZATION OF SELECT PREMISES WITHIN THE CAMPUSES OF ISABELA STATE UNIVERSITY AS QUARANTINE FACILITIES FOR COVID-19 PUIS and PUMs;

RESOLVED FURTHER, that sufficient health safeguards and safety protocols be established in the Memorandum of Agreement which will ensure COVID-19 containment, and stipulations which will guarantee the welfare of health workers and other persons who will handle COVID-19 PUIs and PUMs.

RESOLVED FINALLY, to furnish a copy of this resolution to **Honorable Rodolfo T**. **Albano III, Provincial Governor** for his information and further action.
