THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2019-030 of the Municipality of Jones, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- Typographical errors are found in the Savings from Personal Services per Position sheet/form. Typographical errors should be avoided especially in the budget documents which are considered legal documents;
- 2. The appropriation for Monetization of Leave Credits in the amount of One Million Nine Hundred Nine Thousand Twenty Two Pesos & 34/100 (P1,909,022.34) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016, on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
- 3. The appropriation for the grant of Collective Negotiation Agreement (CNA) in the amount of One Million Seven Hundred Ninety Three Thousand Nine Hundred Fifty Eight Pesos & 57/100 (P1,793,958.57) shall be in accordance with DBM Budget Circular No. 2019-5, dated November 7, 2019, on the Guidelines on the Grant of Collective Negotiation Agreement (CNA) Incentive for FY 2019;
- 4. The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of One Million Nine Hundred Thirty Thousand Pesos (P1,930,000.00) shall be in accordance with Administrative Order No. 19 by the President of the Philippines, dated December 2, 2019, Authorizing the Grant of Service Recognition Incentive to Government Employees for Fiscal Year (FY) 2019;
- 5. The Utilization of the Appropriation for Other Professional Services amounting to One Hundred Eighteen Thousand Pesos (P118,000.00) shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units.

RESOLVED FURTHER, to require the Municipality of Jones, Isabela to comply with the herein review findings and/or conditions.
