WHEREAS, the Philippine Bar Examinations (Bar Exams for brevity) is the professional licensure examination for lawyers in the Philippines, with the same being recognized as one of the most – if not the most difficult licensure examination in the country;

WHEREAS, the past five Bar Exams (2014-2018) have an average passing rate of 29.62%, with the 2014 Bar Examinations registering the fewest passers at 18.82% of the total examinees;

WHEREAS, examinees have to undergo years of physically, mentally, and financially exhausting training in law school in order to qualify for the Exams; and again, have to undergo four more grueling weeks of examinations, covering eight subjects, to complete the Bar Exams;


WHEREFORE, premises considered, upon motion of **Honorable Faustino G. Dy III**, duly approved and seconded in a session duly assembled it was –
