WHEREAS, it is the policy of the Provincial Government of Isabela (PGI) to provide Isabeleños with effective medical care and services;

WHEREAS, pursuant to Republic Act No. 11465, otherwise known as the General Appropriations Act for Fiscal Year 2020, the Department of Health – Cagayan Valley Center for Health Development (DOH-CVCHD) was allocated with One Million Pesos (Php 1,000,000.00) for the implementation of the Medical Assistance Program (MAP);

WHEREAS, the MAP is established to ensure the ready-availability of medicines and other health care services for qualified indigent and poor patients;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous to the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the PGI;
