WHEREAS, it is the policy of the Provincial Government of Isabela to provide all local government units within its authority with ample support and appropriate assistance for the stimulation of growth and development in their respective jurisdictions and for attaining a comprehensive economic prosperity in the entire Province:

WHEREAS, the Deed of Usufruct, if agreed to and signed by both parties, will grant the City Government of Ilagan, Isabela with the right to utilize the Old Provincial Jail and the land to which it is situated, which are both owned by the Provincial Government of Isabela, for purposes of its rehabilitation and its later use as an economic facility for small-scale businesses;

WHEREAS, the Local Government Code empowers local government units to utilize their resources in accordance with their priorities;

WHEREAS, considering that the Old Provincial Jail has been idle and inactive for a long period of time, this Honorable Body deems it proper and beneficial to the Province to have the same be rehabilitated and be utilized as an economic facility for small-scale businesses as such will promote local employment in the City of Ilagan, Isabela and will further advance the Province's continued economic advancement;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Marco Paolo A. Meris, duly approved and seconded in a session duly assembled it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF USUFRUCT WITH THE CITY GOVERNMENT OF ILAGAN, ISABELA FOR THE REHABILITATION OF THE OLD PROVINCIAL JAIL AND ITS UTILIZATION AS AN ECONOMIC FACILITY FOR SMALL-SCALE BUSINESSES
