WHEREAS, there is an existing and urgent necessity to further strengthen the capacity and capability of the Provincial Government of Isabela to contain, address, and resolve the spread of COVID-19 in the Province;

WHEREAS, AJ ENTERPRISES has offered to implement the iGUARD Security and Contact Tracing System in the facilities of the Provincial Government of Isabela;

WHEREAS, as presented by AJ ENTERPRISES, the iGUARD Security and Contact Tracing System is a computer program system that strengthens and improves the contact tracing capabilities of availing entities by eliminating the *manualness* of usual contact tracing mechanisms and accelerating contact tracing efforts through SMS notifications and text blasting to suspected and possible COVID-19 patients;

WHEREAS, this Honorable Body acknowledges the importance and necessity of introducing innovative and effective solutions in the Province's fight against the pandemic, and recognizes the advantages and benefits of introducing the iGUARD Security and Contact Tracing System in the facilities of the Provincial Government of Isabela;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Emmanuel Joselito B. Añes, duly approved in a session duly assembled it was –
