WHEREAS, the Provincial Government of Isabela is duly empowered by law to execute powers necessary, appropriate, or incidental to promote the health and safety of its people;

WHEREAS, the Provincial Governor, Honorable Rodolfo T. Albano III, requested the assistance of the Department of Public Works and Highways Regional Office No. 02 (DPWH R02) for the construction of isolation and COVID-19 testing facilities in the Province of Isabela;

WHEREAS, DPWH R02 welcomed such request of the Provincial Governor and thus made an undertaking to construct a DPWH Standard One (1) Storey Health Facility Container Van with swabbing booths within the compound of Echague District Hospital in Echague, Isabela

WHEREAS, the realization of such request, and the concomitant project, necessitates the execution of a Memorandum of Agreement between the Provincial Government of Isabela and DPWH R02;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan

WHEREAS, this Honorable Body considers this endeavor of the Provincial Governor as consistent and in advancement of the anti-COVID-19 policies and measures of the National Government, and will further develop the capacity and capability of the Provincial Government of Isabela in resolving this health crisis;

WHEREFORE, premises considered, upon motion of Hon. Faustino U. Dy IV, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
