EXPLANATORY NOTE

WHEREAS, the COVID-19 pandemic has severely diminished government funds and limited revenue sources. Accordingly, there exist a necessity to find new fund sources that will ensure the efficient and continued implementation of government programs and services aimed at promoting and safeguarding the health of the people;

WHEREAS, the COVID-19 pandemic has stretched the capacity of hospitals to their absolute limits and underscored the need to improve local health facilities due to the complexity in handling COVID-19 cases;

WHEREAS, there exist an immediate need to upgrade all hospitals operated by the Provincial Government of Isabela in light of the continuing spread of COVID-19 in the Province and to further ensure that Isabeleños are provided with safe, quality, and reliable medical service amidst the ongoing pandemic;

WHEREAS, the Provincial Government of Isabela entered into a Loan Agreement with the Development Bank of the Philippines in the amount of Two Billion Nine Hundred Million Pesos (Php2,900,000,000.00) which was utilized to fund various developmental projects and the construction and rehabilitation of the Ilagan-Divilacan Road;

WHEREAS, the loaned amount was divided into two purposes: First, for Various Development Projects amounting to Php1,300,000,000.00; and two, for Construction/Rehabilitation of Ilagan-Divilacan Road amounting to Php1,600,000,000.00;

WHEREAS, the Various Development Project, as stated above, is broken down as follows:

WHEREAS, as of February 1, 2021, there are still unreleased amounts under the Various Development Projects;

WHEREAS, this Honorable Body is of the stand that utilizing a portion of the said unreleased amounts for the purpose of upgrading the capacity and modernizing PGI hospitals to be proper and efficient use of available government funds considering the current scarcity in fund sources and the urgency to ensure the continued implementation of government health services and medical programs especially amidst the ongoing global pandemic. However, the current structure of the Php2.9B PGI loan with the DBP limited the funding for the improvement of PGI hospitals to only the Governor Faustino N. Dy Sr. Memorial Hospital;

WHEREAS, there is a need to include all other provincially operated hospitals in the improvement of hospital building structure;

WHEREAS, the Provincial Governor, Hon. Rodolfo T. Albano III, is hereby granted with the necessary authority to sign on behalf of the PGI all papers and documents that are necessary to effectuate the aforesaid amendments to the Loan Agreement with DBP;

WHEREFORE, the speedy passage of this Ordinance is earnestly sought.

Section 1. Purpose. The aim of this Ordinance is to broaden the purpose and utilization of unreleased amounts under the item "Improvement of Building Structure" in the agreed Loan Purpose of the P2.9Billion PGI loan with the DBP. Accordingly, the agreed loan purpose which limited the funding of improvement/upgrading of hospitals to only the Governor Faustino N. Dy Sr. Memorial Hospital is hereby expanded to include all district hospitals operated by the PGI.

Section 2. Amendatory Clause. The Loan Purpose as stated in the Loan Agreement is hereby amended as follows:
