### EXPLANATORY NOTE

WHEREAS, this Honorable Body passed Ordinance No. 22, Series of 2019 which authorized and approved the 2020 Annual Budget of the Provincial Government of Isabela:

WHEREAS, the PGI 2020 Annual Budget appropriated funds for the Payment of Loan Amortization;

WHEREAS, with the on-going COVID-19 pandemic where funds are depleted and financial status is uncertain due to decrease in revenues and collections, the PGI deemed it proper to reprogram the Payment of Loan Amortization to various infrastructure projects including among others the Construction of Bangag Water System, Sta. Maria, Isabela as an effective local fiscal measure and sound monetary policy to ensure the achievement of economic progress, growth and development;

WHEREAS, however, with the rehabilitation of the pumping station in the nearby town, several barangays benefited which enhanced the delivery of water services of Barangay Bangag among others, hence, the need to reprogram the said project to a barangay in need of access to clean water system;
