#### **EXPLANATORY NOTE**

WHEREAS, Republic Act (RA) No. 11469 (the Bayanihan to Heal as One Act) granted the President the power to adopt various temporary emergency measures to respond to crisis brought about by the Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, to effectively carry out the said measures, the National Government allocated funds to augment the resources of the local government units through the Bayanihan Grant to Provinces (BGP);

WHEREAS, pursuant thereto, this August Body enacted Ordinance No. 2020-13-2 otherwise known as An Ordinance Authorizing Supplemental Budget No. 01 of the Provincial Government of Isabela for Fiscal Year 2020 in the Amount of One Hundred Thirty Six Million Seven Hundred Seventy Six Thousand Five Hundred Fifty Pesos (Php136,776,550.00);

WHEREAS, Section 5 of Ordinance No. 2020-13-2 provides that any item may be augmented or reprogrammed in other items within the same appropriation in accordance with Local Budget Circular No. 126 dated April 13, 2020 and other pertinent budgeting, accounting and auditing rules and regulations;
