MEMORIAL HOSPITAL, CAUAYAN DISTRICT HOSPITAL, MANUEL A. ROXAS DISTRICT HOSPITAL AND A LOT NEAR THE POWERHOUSE IN THE CAPITOL COMPOUND

WHEREAS, the Provincial Government of Isabela is the registered owner of stalls at the Provincial Capitol Food Court, Governor Faustino N. Dy Sr. Memorial Hospital, Cauayan District Hospital, Manuel A. Roxas District Hospital and a lot near the Powerhouse in the Capitol Compound;

WHEREAS, due to the impending cessation of the Contracts of Lease for stalls at the Provincial Capitol Food Court on June 30, 2021, a renewal of Contract was hereby presented and its commencement has been recommended on July 1, 2021 to June 30, 2022;

WHEREAS, leased stalls at the Governor Faustino N. Dy Sr. Memorial Hospital, Cauayan District Hospital, Manuel A. Roxas District Hospital and a lot near the Powerhouse in the Capitol Compound will also be terminated on July 31, 2021, hence, its renewal has been recommended to begin on August 1, 2021 until June 30, 2022;

WHEREAS, this Honorable Body recognizes that aside from the revenue which PGI will receive from rental fees of the leased stall units, authorizing the renewal of leasing the units at the Provincial Capitol Food Court, Governor Faustino N. Dy Sr. Memorial Hospital, Cauayan District Hospital, Manuel A. Roxas District Hospital and a lot near the Powerhouse in the Capitol Compound will generate continuous business, employment, and livelihood opportunities for the lessees and their workers — all in accord with the policy and aspiration of the Provincial Government of Isabela to provide its people with the necessary assistance for their growth and development;

WHEREAS, granting the Provincial Governor with the necessary authority to sign and renew a Contract of Lease with the lessees and tenants at the Provincial Capitol Food Court, Governor Faustino N. Dy Sr. Memorial Hospital, Cauayan District Hospital, Manuel A. Roxas District Hospital and a lot near the Powerhouse in the Capitol Compound is in conformity with the provisions of Section 465 (b) (vi) of R. A. No. 7160;
