WHEREAS, the Isabela Masonic Lodge No. 60, a local chapter of the Most Worshipful Grand Lodge of Free and Accepted Masons of the Philippines based in City of Ilagan, Isabela, will be celebrating their 100th Anniversary of Establishment on June 26, 2021;

WHEREAS, the Provincial Governor Rodolfo T. Albano III endorsed to this Honorable Body the Request of Isabela Masonic Lodge No. 60 to construct a Centennial Marker with clock within the vicinity of the Queen Isabela Park in honor of their history and the Province;

WHEREAS, this Honorable Body passed Resolution No. 2021-19-02interposing no objection to the said request of Isabela Masonic Lodge No. 60;

WHEREAS, in fulfillment of this commitment, the Provincial Governor submitted a Letter to this Honorable Body requesting for an authority to sign on behalf of the Provincial Government of Isabela a Memorandum of Agreement which will permit the Isabela Masonic Lodge No. 60 to construct and maintain a Centennial Marker over a 16-square meter portion of the Queen Isabela Park;

WHEREAS, this Honorable Body finds the Memorandum of Agreement to be reasonable, lawful, and consistent with the pronouncements it expressed in Resolution No. 2021-19-02;

WHEREAS, Section 465, par. (b)(1)(VI) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Hon. Marco Paolo A. Meris, duly approved and seconded in a session duly assembled, it was –
