WHEREAS, the Fourmula One Plus for Health, with its tagline "Boosting Universal Health Care", is a strategic framework for Health Sector Reform to attain the goals outlines by the government in the Philippine Development Plan, the Sustainable Development Goals, and the Ambisyon Natin 2040;

WHEREAS, the Province of Isabela has agreed to implement health sector reforms, programs, projects, and activities consistent with the Universal Health Care Act and the Fourmula One Plus for Health in partnership with the Department of Health-Center for Health Development (DOH-CHD), Cagayan Valley;

WHEREAS, for the release of the allocated P 2,726,665.00 support (Financial and Non-Financial Grants) from the National Government-DOH, opening and maintaining a Trust Fund Account to be known as the "DOH Health Fund" with the Land Bank of the Philippines, Ilagan Branch is a condition sine qua non;

WHEREAS, Section 465, (b) (vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, granting the Provincial Governor with the necessary authority to open a Trust Fund Account on behalf of the Provincial Government of Isabela will result in the enhancement of the capacity and capability of the local government to extend the much needed programs, initiatives and services to its people, hence, advantageous and beneficial to the Province;
